Part 1: "Reasons Why U.S. Government CAN'T Release Truth About UFOs!"

with Canadian Researcher, Grant Cameron

Reporter Sarah McClendon: Mr. President, why don't you do something about the ET cover-up?'

President Bill Clinton: 'There's a government inside the government and I don't control it.'

December 21, 2004 Winnipeg, Manitoba, Canada - Last month in Las Vegas at the MJ-12 UFO Crash/Retrieval Conference, Canadian researcher Grant Cameron and I talked about several reasons why the U. S. government continues to sustain a strict policy of denial about the extraterrestrial phenomenon even while it has back engineered physical objects retrieved from several UFO crashes since at least the early 1940s (For example, Cape Girardeau, Missouri, in 1941).

Recently Grant told me he is working on a paper for lecture presentations in 2005 that will list "64 Reasons Why the U. S. Government Hasn't Released Truth About UFOs!" His list is not completed, but Grant talked to me for Earthfiles and *Dreamland* about his growing list of non-disclosure reasons (27 listed below), in spite of his conviction that all humans deserve to know the truth about other life in the universe interacting with our planet.

Interview:

Grant Cameron, a building facility manager at the University of Manitoba; reporter and producer of www.presidentialufo.com, Manitoba, Winnipeg, Canada: "Why do the people whoever control this why have they decided to cover it up? I've made two assumptions:

- One is that they are not evil men. They might do evil things. They might be deluded
 or whatever. But I think the majority of them are people who think they are doing
 the best for the American people, or whoever they think they are working on behalf.
- Two, the other thing I assume is there is a process of discussion and review. There have been numerous discussions about a possible split inside this control group alleged to be MJ-12 (Majestic 12 appointed by President Harry S. Truman). Supposedly some want to release and some people don't want to release. Indirectly working in government here, I know if you are part of government, you spend an awful lot of your time with policies and protocols and procedures, so I am assuming there is some sort of processed paperwork. It might be fifteen levels deep in security, but there is some sort of process in which someone has sat down, looked at the whole UFO scene and the ET visitations all the different aspects and have made a conscious decision to say, 'No, we're not going to release it.'

Then I tried to look at if I were on their side and the prime example I always use is if you take an honest man like Jimmy Carter. He went into the White House, had seen a UFO, was determined when he got into the White House to release the UFO files, went into the White House and it does appear that he was briefed on the subject. Then, according to the actress Shirley MacLaine, he said that it was true, there *were* occupants. He wanted to shine the 'sunshine laws' on the UFO subject to see how the people would react, but that he could not and would not. That seems to indicate that he knew what the story was and he had decided he couldn't and wouldn't release the UFO secrets.

So, what I look at while I'm writing this article and what I've always thought about is: If I were given the same briefing that Jimmy Carter was given, would I change teams like Jimmy Carter did? We had a guy who actually was on our side and went to their side. Why?

IF YOU WERE IN JIMMY CARTER'S SHOES, WHAT DO YOU THINK WOULD BE THE REASONS HE DECIDED THAT KEEPING EVERYTHING SUPPRESSED IN A POLICY OF DENIAL IS STILL THE BEST POLICY?

Jimmy Carter, I think, spelled it out himself why he decided to keep it a secret. He made a statement that I think some people have not heard. He stated that he was going to release the UFO files, but it had to do with national security, secret weapons he referred to, that kind of stuff and said, 'I wouldn't release that, but I have no problem releasing the UFO files.'

So, if you are a briefer and you wanted to turn the President and every President appears to have turned (to non-disclosure side) and every President has gone along with this policy.

Reasons For Non-Disclosure

1) National security. Basically that sort of goes over all the 64 reasons it can encompass all of them, the national security. That's the big one, the main one, even though I haven't tried to rate them in terms of importance. But national security in terms of if we released weapons information, if foreigners get hold of this. The government insiders could easily tie this into national security if we release the whole story. So, I think national security is number one.

Inside national security, the government's priority is:

2) Weapons development and military's Need-To-Know elite.

3) Technology development lead time.

4) Reverse engineering. Back-engineering of alien technologies from UFO crash retrievals and getting those technologies functional in the American space and corporate-industrial programs and patents. (See book: *The Day After Roswell* by Lt. Col. Philip J. Corso © 1989.) Trying to get as much done to develop this technology before we have to release the truth. A Need To Know policy it's a concept that the military has. It's sort of like, 'We're the military and we're going to do the thinking and therefore, we have a need to know and the general population does not. We are not going to release it because it's part of the military. It's our secret. It's not part of what the population should know.'

So you get this thing where someone has a TOP SECRET clearance. I am special and I have this need to know.' You want to maintain this sort of special status that you have.

Some of the other ones that I looked at were:

- 5) Complexity. When you start looking at all the 64 reasons, you realize that the UFO situation and a lot of researchers know this, but the public does not know this it is actually a very complex subject. It's not simply 'ET's are here.' There are all sorts of complications in terms of abductions and mutilations and all sort of things, crop circles. The more you look at it the more complex it gets. That in itself is more reason why they are trying to sit back and understand it better. It's a very complex thing and very hard to explain to the people. That would be one of the reasons.
- 6) Abduction phenomenon. I think that is one of the key reasons they don't release. George W. Bush just recently came to Canada. He made a speech in Halifax, Nova Scotia. In that speech, he tried to promote the idea that Canada should get involved with this space-based-weapons stuff. In there, he stated that to keep our people safe, that is the most solemn duty I have. Constitutionally, the President is responsible for the protection of the American people. Some of the estimates of abduction numbers run to 6 to 8 million people. I think the President not only does not know how to stop abductions, I don't think he even knows why abductions are taking place. So, this is the kind of thing that you can't put the President or governments, for that matter in front of people to make them look stupid. It's something they can't deal with and they are postponing it until they can get control of it.
- 7) Psychological warfare. If you look at the psychological warfare that's involved in abductions, this is like candy to intelligence agencies that you can actually abduct a foreign leader, go into his mind, find out what he is thinking, feed stuff into his mind. This is very powerful stuff they might want to work on behind the scenes.
- **8) Animal mutilations.** It sort of confirms the fact that there is an evil element to this thing. Even when I researched, people believed they were angels of God, people who believed they were angels of the devil. The whole mutilation thing gets into the fact there

might be an evil element to the alien presence.

OR EVEN JUST SURVIVAL THAT DEMANDS GENETIC HARVESTING. AND THE FACT THAT WE ARE KEPT IN THE DARK AND UNCONSCIOUS ABOUT OUR PLANET AND ANIMALS AND OURSELVES BEING HARVESTED IN AND OF ITSELF HAS A NEGATIVE UNDERBELLY.

Sure, it's scary stuff. The media people could really spin this whole thing to make it look very bad.

SO ON OUR LIST, WE START WITH NATIONAL SECURITY, AND THEN WE GO TO ABDUCTIONS THAT ARE VERY COMPLEX. AFTER THAT THE WORLDWIDE ANIMAL MUTILATIONS HAVE BEEN GOING ON FOR AT LEAST 60 YEARS. AFTER YOU GET PAST THOSE THREE CATEGORIES, CAN YOU TICK OFF WHAT OTHER ITEMS YOU HAVE ON YOUR GROWING LIST?

9) Alien cover-up. The aliens are covering up as well, which I'm sure disturbs the American government to no end. Why are the aliens not releasing? And yet, another one that involves that is: Are the aliens in control? Have the aliens made, told the government to cover this thing up? Are they being controlled like the "alien masters?" So there is this whole thing that the aliens aren't releasing if they are staying in the background and not announcing themselves, we're (human governments) not coming out first. There is this fear of why the aliens are not there.

MEANING, WHY ARE THEY KEEPING IT SECRET AS WELL?

Exactly, and that makes for distrust. Or that the aliens might have actually said, 'You can't release it.' We don't know. There might be something behind the scenes where the aliens say you can't release it (because they are) the "alien masters.'

10) Government gridlock: The whole thing that Whitley Strieber talked about when he interviewed Lawrence Rockefeller. Lawrence Rockefeller, during the Clinton administration, had tried to get the Clintons to release the UFO story through declassifying everything. The Clintons we know were very interested. Hillary was going through third parties to researchers. They were very interested. But when Lawrence actually sat down with I think it was Hillary. Some people say the President was there, but I don't think he was there. Hillary was there and actually went through the briefing (with Rockefeller) and described to her why UFOs should be released, why this is an important subject. Hillary came back after the briefing the next morning and said, 'Don't ever bring up the subject again.'

Part of that was that the Clintons were the people who wanted to release it, but they couldn't release it. They already had Monica Lewinsky. They had all sorts of scandals going. Hillary had been tied in with this Jean Houston out of New York and channeling dead people (Eleanor Roosevelt). It was very embarrassing, so it was something that even though they wanted to do it, the Clinton Administration, it was a giggle factor thing where they didn't need it. It wasn't something that was going to get them anywhere, so they basically backed away from trying to force disclosure.

BUT YOUR IMPLICATION IS IN YOUR RESEARCH THAT CLINTON, THE PRESIDENT, DOES KNOW MORE ABOUT SOMETHING HAVING TO DO WITH AN EXTRATERRESTRIAL PRESENCE ON THE PLANET THAN HE HAS EVER ADMITTED?

Yes, and like everything else people don't realize the President does not have so much power. He can't just come in and take an idea and bring it out. That's not the way it works. You have to put it through Congress, you have to have the backing of Congress. You have to have the lobbyists on your side. There are all sorts of different things that are involved. Even though Clinton wanted it, I was told inside the CIA that they (Hillary and Bill) were both looking. They were very interested in UFOs. They were contacting admirals and different people and asking them about UFOs. The Clintons were very interested. Even when I was lecturing at the Ozark conference last year, one woman came up to me and said her sister owned a barbecue restaurant where Bill and Hillary went and that they had a UFO sighting. So, there are all these indications of their interest. They asked Webster Hubble to go out and get the information on UFOs. They had a number of indications that they tried to get it and it was like they kept banging against the wall and finally decided it was not worth it and gave up. They gave up on disclosure. They tried, but it's the same as Jimmy Carter tried.

IF CLINTON AND CARTER WERE UNACCEPTABLE TO THE MJ-12 POWER CONTROLLERS ON THE EXTRATERRESTRIAL BIOLOGICAL ENTITY STORY, WOULDN'T YOU THINK THAT GEORGE W. BUSH, THE CURRENT PRESIDENT, WOULD BE ACCEPTABLE BECAUSE OF HIS CONSERVATIVE STANCE? IF SO, DO YOU THINK THERE IS ANY CHANCE THAT THIS ET STORY, THE TRUTH ABOUT

IT OR AT LEAST THE BEGINNING TRUTH, COULD OPEN UP IN THIS SECOND ROUND OF THE BUSH ADMINISTRATION?

I don't think so because of this: the Democrats want disclosure. It's like Bill Clinton he talked about his new library that has a lot of glass and a lot of light and this is to show that the Clinton Administration was an open administration. They declassified 800 million pages of documents. That was their thing. So was Jimmy Carter. The vast majority of documents we have today came out during the Carter Administration. So, they wanted openness, but because they were not liked by the military, they were cut out of the loop. The Republicans, on the other hand, they have the power and association with high ends of the military. The problem is that they work in an aspect of secrecy. Dick Cheney, for example, the Vice President, one of his ideas is if you have the three branches of government - the judiciary, the legislative and the executive - he wants the executive branch to be stronger. Therefore, you have a policy of no disclosure of any conversations of anything that goes on inside the executive White House.

And that is the policy the Bush Administration has used. You want to work on UFOs in secrecy because you don't want to air your dirty laundry, the things that are going on, the disagreements, the things that are not working. You want to work in secrecy and keep it away from other nations. That's the mentality that the Republican Administration seems to have, sort of a paranoid mentality about the fact that the world is out to get us and there are evil forces in the world and we are called by God to do this. You saw it in the Reagan Administration and in this Bush Administration. That's why even though they have the power George W. Bush made Roswell jokes when he went to Roswell, he made the joke about the unidentified object over town that morning and then jokingly said, 'Oh, no, that was me in Air Force One.'

So he knows the story, he makes little jokes about it. He probably knows but for him he would definitely see it as an aspect of military weapons development, back engineering, the fact that we have terrorism. This might help us to fight terrorism and North Korea and all the enemies we have around the world. To do it, we have to do it in secrecy. We can't be leaking stuff out. I think Dick Cheney is a big part of keeping things secret.

YOU AND I HAVE TALKED ABOUT WHAT SEEMS TO BE A PRETTY CLEAR INDICATION THAT 4-STAR GENERAL WESLEY CLARK HAS HAD SOME KIND OF BRIEFING ON THE UFO STORY. IF HE HAS, WOULDN'T CHENEY, WOULDN'T BUSH, WOULDN'T THE CURRENT HIGH RANKING PEOPLE IN THE WHITE HOUSE, ALL HAVE HAD A BRIEFING AS WELL?

Yes, I think all those people have been briefed. I asked Vice President Cheney right after he came into the White House. I asked the briefing question: 'Mr. Cheney, in all your jobs in government, have you ever been briefed on the subject of UFOs? If so, when was it and what were you told?'

And he said, 'If I had been briefed on that subject' he did not mention the name, he said 'that subject' 'it probably would have been classified and I wouldn't be talking about it.' That comes down to the military aspect that it's tied into national security. You have to have security in these programs and I'm going to play the good role and not going to talk about it.

Wesley Clark was more indirect and tried to talk around the subject the same as George Bush, Sr. He was asked on the campaign trail and he had been Director of Central Intelligence the bushes are seen as very strong leaders, going to war. But Bush when he came in was seen as a very weak Vice President. he had been Director of the CIA. When he was asked by Charles Hufford, 'Come on, you were CIA Director. You know what's going on. Are you going to release the UFO information?' He said, 'Yes, I know a little bit.' Almost what Wesley Clark had said, 'Yes, I know a little bit about what's going on.'

SO NATIONAL SECURITY KEEPS COMING AROUND FULL CIRCLE AS ONE OF THE MAIN REASONS WHY THIS COVER-UP HAS BEEN PERPETUATED FOR AT LEAST 60 YEARS FROM THE TRUMAN ADMINISTRATION, MAYBE EVEN BEFORE. AND THE ANIMAL MUTILATIONS AND ABDUCTION SYNDROME COMPLICATE THE ABILITY OF THIS GOVERNMENT, OR ANY GOVERNMENT, TO OPEN UP THIS COMPLEX AND POSSIBLY DANGEROUS SUBJECT. ON YOUR LIST OF TRYING TO SAY 64 REASONS FOR WHY THE POLICY OF DISCLOSURE SHOULD STILL BE IN PLACE, WHAT ELSE IS ON YOUR LIST?

11) Population resistance. The fact that the population will resist any sort of attempt to integrate aliens into society. They fear this, some of these things are what people fear, they are not 100% sure, but we are better off just leaving off. That's something government insiders are scared of population resistance.

12) Collapse in belief systems. It's scientific people who are going to really take a bath on suddenly realizing the vast majority of things they believed are wrong.

- 13) Religious collapse. How are the Arabs going to deal with this, for example? You can't just look at Americans. Worldwide, how are different cultures going to deal with this whole scenario?
- 14) Past lying statements. The fact that you are tied into lying for 60 years, you are sort of stuck. You have to keep telling one lie to cover up the other lies of the past.
- 15) Old style conservatives. This is not a big issue. But, basically it's that in religions, you have old style conservatives who resist. Thus, new ideas aren't born; old ideas just die way. More and more of the young people believe in ETs and the older people don't want new concepts. It's conservatives that are blocking release of different truths.
- 16) Kick backs and profits. Behind the scenes is probably a very highly classified program and there is probably a lot of money exchanging hands, a lot of kickbacks, a lot of people who are going to fight tooth and nail to keep the system the way it is because there are a lot of people making money on the technology and what's going on. They are not going to give that up without a fight.
- 17) Loss of power. Whether it's government or people running the thing, you are going to lose if the system changes with the release of the extraterrestrial truth. The people who are in power now are no longer going to be in power. That's almost for certain. These people don't want the power to shift away from them.
- 18) Dependence on oil. The entire economy is based on oil. It's the whole fact that if we are so dependent, so used to oil-driven engines, that we can't break that tie. We are so reliant upon oil it's almost like an addiction to a drug. Another big reason tied to oil is:
- 19) Crash of the stock market. I believe the stock market would crash. I was first warned about this when I used to study the guy, Wilbert Smith, who used to run the Canadian government's UFO program. One of his close associates was a military scientist who did the metallurgy work when pieces came up from the United States to Canada to be analyzed. He did the metallurgic work. I had a number of interviews with him back in the 1970s. He sort of stopped the conversation and said, 'Grant, let me tell you something. I want to warn you about something. If you know they are going to disclose the UFO story tomorrow morning, I'm telling you, I'm warning you, sell everything you've got today because tomorrow nothing is going to be worth anything. When you think about that, it's actually true. The stock market works because people are going to buy stocks according to what they think a stock will be worth tomorrow. You want to make money on it. If you think a stock is going to be worth less tomorrow, you're not going to buy the stock. As soon as the UFO truth is released, stocks become worth literally nothing. Everybody who has oil stocks will start to sell. Anyone who feels tied in, whether it's the car industry, anything that has to do with engines they are going to figure 'I have to get out before my thing melts down.'

So, why would the President and his advisers rock the boat? Why would they take the big chance? We are doing OK. Let's spend another ten years, we can get another pile of answers to abductions, mutilations, back-engineering ET technologies and all the different things we're working on. If you disclose ten years from now, we'll be a lot farther ahead in dealing with the problems we're going to have and in back-engineering the technology than we are right now. 'So, Mr. President, why take the chance? Why would you go out on the limb and risk people panicking?""
