Updated: Viewer Letters About NASA Airbrushing Photos; EBENs and Reptilian Eyes in Humans.

June 18 - 19, 2006 Albuquerque, NM - On June 7, 2006, I interviewed Gary McKinnon in London about his gaining access to NASA and American military computers in 2000 to 2002, which did not have firewalls and only password defaults. [See link in More Information below.] What provoked Gary to try such illegal access was the testimony of a former NASA photo technician, Donna Hare, who said NASA was airbrushing UFOs and UFO-related objects out of photographs on the moon. Gary believes the U. S. and his home country, the U. K., have secretly back-engineered extraterrestrial technologies that could provide energy at this critical time on Earth when petroleum is dwindling and the average citizen's gasoline, air conditioning and winter heating bills are rising so rapidly, many people cannot pay them. Gary wants the UFO secrecy cracked open and whatever secret energy systems there might be revealed to the world so cheaper, or free, energy can be accessible to all citizens.

After I reported that interview, I received the following e-mail on June 8, 2006:

"I was listening to the latest report you did with the English "Hacker"? and was reminded of an incident that took place after I graduated from high school in Houston. I had a couple of close friends there and in our senior year we were pretty much inseparable. As it got closer to our graduation in the 1960s, we were finding jobs to make money for graduation and deciding what we would do about college.

One friend in particular went to work in a warehouse at Ellington AFB for a contractor at NASA and his job, as he described it, was he took the pictures brought back from space by the astronauts and they were transferred by a machine he ran to microfilm. During the next three years he stayed doing the same job and was not a permanent employee in that when they had work for him he was called and as the end of the 60s neared and the moon landings took place he worked more and more.

He got married before me and as such spent more free time with his wife than with me and my girlfriend. When I got married, he was in my wedding and we spoke of an incident he had told me about before and we recalled that he had seen these in the past but was told not to speak to anyone about them. He was always very cryptic and would only say there were things in space and on the moon that were not man made but were machines. Part of his job was if he found them (alien machines), he was to report them and log the microfilm numbers.

I had no contact with him for several years and he avoided all attempts for any of us to get hold of him. Then there was a recent high school class reunion and I had found his name in the registry. I contacted him to see if he would be coming to the reunion. He was living at the time in the southwest and remarried. He was trying to see if they were going to be able to come and he would let me know. I sent him several emails and we had set up a slight communication until I said I had not heard from him since I had asked him about the pictures he had worked with at NASA. He has had no communication with me since and will return no calls. Strange."

The next day, I received the following e-mail about one female's experience with extraterrestrial biological entities in Akron, Ohio, in 1995, in age 9.

"My 1st and only encounter occurred in my home town of Akron, Ohio, when I was the very young age of 9. First let me state that a few days before leading up to my experience, I would always feel like I was being watched, and I would often be awakened with bright lights that would strobe through my bedroom.

Well, it all happened on a hot summer night in 1995. At that time I would always sleep with my covers over my head due to the constant feeling of deeply being watched. The night was muggy as I was restless under my covers and I felt that same presence only stronger than ever this time right next to me. The tension was so terrifying that I was overwhelmed with an impulse to confront the unknown. So I threw the covers off of me and turned to face it at the same time. What I seen only added to my fear.

The visitor stood about 4 ft tall. It had a transparent greenish blue texture like that of Northern Lights, and it had very little to no features. Its eyes were large and almond-shaped and it resembled to be what everyone recognizes now days as a 'grey.'

In a fit of panic I quickly covered myself with the blanket hoping that it would leave me, but as I lay there it literally tugged at the blanket and it would persistently tap or touch me as if to tell

me to face it. Let me state that there was an overwhelming feeling of fear to an extreme. So fighting the fear and realizing that the being was not going to leave, I once again pulled the covers off of me and confronted it only to find that there were two more of them. Besides the visitor next to my bed, there was one at the foot of my bed and one in the door way of my room.

Now, around the same time that I made contact with the visitors' eyes, I found myself paralyzed and unable to move or speak. As I tried to speak, all that would escape was a mere whisper. They then telepathically spoke among each other through me in some sort of strange gibberish type of language. After their conversation, I blacked out, felt myself being lifted off my bed and carried off, and then I felt myself being lowered back onto my bed. So I seem to have some sort of missing time.

These beings seemed to almost be in a partially physical form. I could actually almost see my dresser through the visitors. I am now 20-years-old and even though this happened years ago, I still remember it like it was yesterday. It truly changed my life."

Also, on June 8, 2006, I received the e-mail below following up my Earthfiles reports about people who have seen a girl friend and a good friend suddenly and briefly "replaced" by a standing-up-lizard or reptile, without explanation or understanding of what happened:

"I don't have a replacement story for you, but something from my high school days has always bugged me. I went to school at East Central High School in Tulsa, Oklahoma, from 1964 to 1967. In around 1965 or so, a family moved into our school district from overseas (father was military) and the kids enrolled in school. I think there were four that enrolled, and one of those was extremely strange.

He had pale blue eyes with *vertical* pupils. It was always kind of creepy being around him, but the family as a whole was very social and outgoing. The parents even hosted some parties having kids over from school. It was explained to me that the boy was adopted along with his sister when they were stationed in Germany.

I never really understood why someone would adopt when you already had kids, but stranger things have happened. Stranger yet, none of the kids are listed in our school registry from that time.

I have never seen or even heard of humans with cat eyes."

Update: More e-mail about vertical pupils in humans:

Received on June 19, 2006:

"I, too, have been 'puzzled' about two instances of seeing those vertical pupils in human eyes (which I had always understood was not possible to be vertical, just by the nature of the human eye design). I am not talking about misshapen pupils from eye injuries, called 'broken yoke,' that we've all seen in people. I mean both eyes had totally vertical pupils, both eyes symmetrical.

The first time was a boyfriend. I was standing at the bathroom mirror putting on make-up and he was standing behind me in the doorway, so I was talking to him while looking at him in the mirror. I saw his eyes and the pupils were distinctly vertical and I must have said something like, 'What's wrong with your eyes?.' He left the doorway and wouldn't let me look at his eyes. He said he'd been told about his eyes by other people in the past, so this must have happened before. I don't recall ever seeing it again in him. (He was Hispanic with very dark eyes and the pupil was not as noticeable as in light colored eyes, so to see the pupils in the first place was bizarre, let alone that they were vertical!)

The second time, I was in a hospital and the girl who was in the other bed had eyes with vertical pupils. I remember the pupils were black and the round colored part (cornea) was hazel colored. Just a human eye, except for the vertical pupils-clearly, distinctly VERTICAL! She also said something to the effect that she was aware how they looked (I guess I must have acted astonished).

I have asked numerous medical people if eyes can have vertical pupils, and no one has ever seen this. I asked a psychiatrist even, since they can prescribe drugs and maybe a drug does this, but he said he had never seen it. I cannot find any information in medical books when I look up 'pupil' either - just references to the 'broken yoke' effect from eye injuries.

Over the years I have just remained puzzled by these two incidents. Hope this helps in your investigations."

Received on June 18, 2006, from Donna Lee, www.tracesfrombeyond.com:

"One of the strangest experiences I've had, happened 18 years ago at Disneyland. My husband and I were in the process of relocating from Northern California to Kansas and decided to spend part of our last Christmas in the area taking our 2 year old daughter to Disneyland.

In an attempt to economize we stayed just outside the park in a motel that provided bus transportation into the park. We boarded the bus early the next morning, grabbing one of the long, bench-like seats that face each other behind the driver. After we settled in, my daughter

fell asleep in my arms and I began to take in my surroundings. I noticed a little boy about my daughter's age sitting directly across from me. His hair was so blond it was almost white, and his eyes were a brilliant blue. His eyes...that's when I noticed his eyes had vertical pupils!

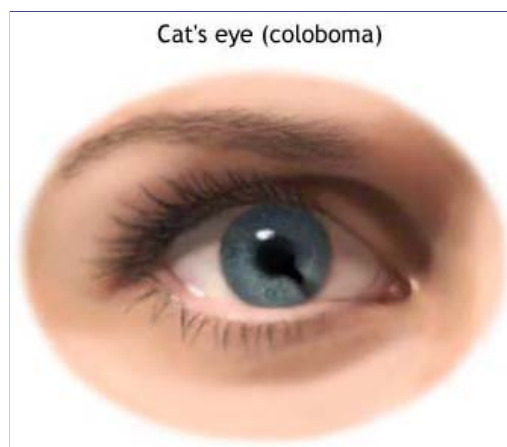
I had never seen anything like it before and tried to find a rational explanation. Did he have some sort of genetic syndrome? He seemed mentally normal and I'd never heard of anything like that. Was he blind? No, I could tell by his movements he was't blind. As I pondered over this unusual little boy, I noticed the sandy-haired man sitting next to him, who I assumed was his father, was intently watching me watch the child, and he had the most sinister, slight smile on his face. I was completely taken aback by his stare, so I turned away.

Just then the bus pulled up to the stop in Disneyland and my husband, daughter and I were the first to get off. As soon as we debarked, I asked my husband if he had noticed the boy with the vertical pupils, but, he had not. I turned around to search for the boy and the man so I could point them out, but they were nowhere to be seen. I watched for them all day but never did come across them."

Received on June 18, 2006, from a radiologist:

"There's a medical condition called coloboma, that has a split iris, sometimes looking like and called 'cat's eye.' There was a kid living in the retirement apartment where my grandparents stayed for several years who had it, and it really was difficult to look him in the eye! Can't remember for sure if it was one or both, but I think it was both eyes. His dad was the maintenance man for the complex. That boy's condition was associated with a syndrome in which half the body is often small (hemiatrophy or hemihypertrophy) and was also associated with Wilms tumor of the kidney. I think coloboma can also be an isolated sporadic or genetic occurrence, or can occur from eye injury."

[Editor's Note: Wikipedia - "A coloboma is the term used to describe a hole in one of the structures of the eye, such as the lens, eyelid, iris, retina, choroid or optic disc. The hole is present from birth and can be caused when a gap between two structures in the eye, which is present early in development in the womb, fails to close up completely before a child is born.
