

July 26, 2007 Albuquerque, New Mexico - In early January 1960, a boy was born to a Kansas family. By age 8, the boy understood that his father worked on very important matters concerning astronauts and NASA's moon missions. His mother seemed to know a lot, too, but the boy was never told exactly what his parents did. However, he vividly remembers the night in 1968 when silver-suited, blond-haired "astronauts" woke him up in his bedroom and he thought they had come home from work with his father.

Interview:

Blond "Astronauts" in Kansas

Kansas Abductee, now 47-years-old and requesting anonymity: "It was in my parents' house in Kansas, in my bedroom. I just remember seeing what I would say were normal-sized people, except they were in spacesuits. That's the best way I can describe it from back then, anyway – kind of a silver, metallic-looking suits. No helmets or anything like that.

HAD YOU BEEN ASLEEP AND THEN WOKE UP?

Yes, I had been asleep and I'm not exactly sure what woke me up, but I remember waking up.

WHAT WAS THE VERY FIRST THING YOU SAW?

A person standing at kind of a 45-degree angle above my bed, just kind of looking at me.

LEANING OVER YOU?

Yes.

WHAT DID THAT PERSON LOOK LIKE?

As best I can remember - because my Dad had told me that he was working on the Apollo mission. At that time, he worked for the Boeing Co. All I remember thinking was, 'Wow! He brought astronauts home.' (laughs)

So, I kind of sat up on one elbow and said, 'Hi.' They just kind of smiled and waved at me.

That person (bending over me) looked just like you or me except he had blond hair.

FEMALE OR MALE?

I had the feeling that it was a male. As I remember, it was kind of what we call a platinum blond and about shoulder length. His physical stature would be that of a normal mid-20s young man, not heavy, not skinny, just kind of normal appearance.

IN A SILVER LEOTARD?

I remember it as a spacesuit. Now that I'm older and think about it, it was more like a tighter fitting garment.

MORE LIKE A JUMP SUIT THAN LEOTARD?

Yes.

WAS IT SILVER METALLIC?

Right. Kind of a Millar color, except I don't remember it being quite that bright, but it was dark in the room.

DID THIS MAN WITH THE BLOND, SHOULDER-LENGTH HAIR HAVE BANGS? OR ALL THE SAME LENGTH?

Best I can remember, it was all the same length, just kind of parted in the middle and pulled back sort of behind the ears or flowing over the ears and down the sides of his face to his shoulders.

WHAT ABOUT THE EYES?

They were blue, I remember that.

WHICH COLOR BLUE?

Real pretty sky blue, or robin egg blue. I don't remember a pupil as such, as much as I do that his eyes were sparkly.

WHAT WAS THE SPARKLE?


It was almost like looking at the sky when the stars first come out.

AS IF THERE WERE GLINTS OF LIGHT IN HIS EYES?

Yes.

THINK OF YOUR OWN EYES – WAS HIS IRIS THE SAME SIZE AS A HUMAN IRIS? OR BIGGER? OR SMALLER?

You know how we have the white of our eye, then the color (iris) and then the pupil? I just remember the blue. There might have been a pupil, but at that age of 8, I was kind of excited (laughs). But I was not scared. It was not like a frightening experience. It was a real calming feeling.

WHAT ABOUT THE NOSE AND FACE?

All three looked about the same. They were paler than me – not as pale as an albino, but like someone who had not been out in the sun very much.

SOME PEOPLE HAVE COMPARED THE COLOR OF THE NORDIC BLOND NON-HUMAN SKIN TO THE COLOR OF A WHITE COTTON SHEET.

Yeah, probably.

WERE THE LIPS ESPECIALLY THIN?

They kind of looked like anyone else's lips, but they were kind of a rosy color, kind of a light pinkish color.

SO IN CONTRAST TO THE VERY WHITE SKIN, THE LIPS HAD COLOR?

Yes, not super pink, but enough to make out the lips.

WERE THE CHEEK BONES PROMINENT?

About like a Native American's cheekbones – kind of high. You could see the bones. They weren't sticking way out, but they looked high like a Native American's face.

ANY ACTOR, ALIVE OR DEAD, WHO MIGHT RESEMBLE THE 'ASTRONAUTS' IN YOUR BEDROOM WHEN YOU WERE 8?

Probably Marilyn Monroe, but with a thinner face.

DID ALL THREE OF THE BLOND BEINGS LOOK EXACTLY ALIKE?

No, one appeared to be a female.

BECAUSE?

Best I can recall, the one standing there by my bed and walked over (toward the other two). Another one turned towards me and smiled. When she turned sideways, it looked like she had breasts. And she had longer hair than he did.

BREASTS, LONGER HAIR, AND WHEN SHE SMILED, WERE YOU LOOKING AT TEETH?

No, I don't think I was. It was not a real big smile, but kind of a gentle, loving smile.

WITH LIPS CLOSED?

Just barely open.

DID HER JUMPSUIT LOOK EXACTLY LIKE THE OTHER TWO WHO WERE MEN?

Correct.

WERE THEY DRESSED IDENTICALLY?

Yes

COULD YOU SEE ANY SYMBOL, PATCH, OR DESIGN?

There was something on the guy leaning over me on his left chest.

IN THE JUMPSUIT, DID IT COME UP LIKE A TURTLENECK, A V-NECK, WHAT?

It covered the arms. I remember it had some kind of cuff on it. It looked different than the rest of the sleeves. It went around the neck half-way up.

SORT OF LIKE A NEHRU COLLAR HALF WAY UP THE NECK?

Yes.

DID IT FIT THE NECK TIGHTLY?

Yes.

WERE THE SLEEVES LOOSE AND LEGS LOOSE? OR TIGHT?

Like the way Spandex material fits bodies.

WERE ALL OF THE SUITS REFLECTIVE SILVER?

Yes.

ANYTHING ON THEIR FEET?

Darker grey, like a sole. I compared it to a spacesuit when I was a kid, but now as I think about it, it looked like the suit blended into a darkish grey inch-thick sole, like a padding.

ALL ONE PIECE AS IF THE FEET WERE APPENDED TO THE JUMP SUIT?

Yes.

DID YOU SEE HANDS?

Seemed to me like they had longer fingers, but other than that looked like normal human hands.

NAILS?

I don't remember looking that close.

WHAT OTHER INTERACTION WAS THERE BETWEEN THE TWO MALES AND THE FEMALE?

At that point, the guy who was bent over me walked around to the end of my bed where the other two were talking. I could hear, but I couldn't understand what they were saying – kind of like they were talking real low.

WERE THEIR LIPS MOVING AS THEY TALKED VERBALLY? OR DO YOU MEAN TELEPATHIC?

It seems like their lips were moving, but not a lot – like they were whispering. At that point, the man (leaning over) walked away and his back was to me and I could see the other two were facing each other. That's when the female turned around and smiled at me. And I remember thinking in my mind – and I don't remember hearing sound – but she was saying that everything was going to be fine.

DID THE TWO MEN WAVE AT YOU?

Just the one, the one that walked from my bed. The other one just kind of stood there looking out my bedroom door, which was cracked.

LIKE ONE WAS ON GUARD. SHE WAS THE MOST EMPATHIC. AND THE MALE BENDING OVER YOUR BED, HE WAVED AT YOU WHEN HE LEFT. SHE WAVED AT YOU AND SMILED. THE OTHER SEEMED TO BE CONCERNED ABOUT WHAT WAS OUTSIDE YOUR BEDROOM DOOR?

Right.

DID YOU GET OUT OF BED?

No, for some reason I did not and I don't know why. I just remember laying there for a second and then I remember her telling me that it's all going to be all right, so lay back down and go to sleep. Everything will be fine.

So, I laid back down, drew the covers over me and lay there a couple of seconds. But I wanted to know more and wanted to talk to them. So, I got up out of bed. I went out into the living room and no one was there. That's when I went and woke my dad up. I told him there were three spacemen in my bedroom. He just smiled and said, 'It will be OK. You just had a dream. Go back to sleep. Everything's fine.' So, I went back to my bedroom.

I remember it took me a long time to go to sleep because I kept waiting for them to come back. (laughs)

Father Says Humans Could Not Handle the Truth About Non-Humans

DID YOU HAVE A DEEPER CONVERSATION WITH YOUR FATHER ABOUT WHY THE ASTRONAUTS WERE THERE AND WERE THEY CONNECTED TO YOUR DAD'S WORK?

In the morning, I asked Dad if he brought the astronauts home. My mom asked what I was talking about. Dad said to Mom that I told him there were some astronauts in my bedroom. He said he told me everything was fine and I was just dreaming.

I asked him again if he brought any astronauts home and he said, 'No, I didn't bring any astronauts home. I don't do that part of the work. I just work on parts for the rockets.'

DID YOU HAVE A SENSE THAT YOUR FATHER KNEW MORE?

I had a sense that he knew exactly what was going on.

DID YOU EVER, BEFORE YOUR FATHER DIED IN SURGERY, TALK WITH HIM ABOUT THAT EVENT?

Yes and he said I was not to talk with anyone about it. He said he knew that everything was fine and if I knew the truth or if people in general knew the truth, it would – because I asked him why he did not go to church. That's how our conversation started. My Dad basically told me that if humans knew the complete truth, it would change religion as we know it today and would collapse religious beliefs. He told me, "There is a higher being and I believe in that. And I feel I'll get to meet him. But other than that, I don't feel I have to go to church."

Then I tried to question him about stuff he did for the military and he told me he could not talk about it.

Satellites and Non-Satellites

BUT DID YOU EVER KNOW IF YOUR FATHER HAD DIRECT KNOWLEDGE OF NON-HUMANS?

I believe he did and I believe he tried to tell me that in so many words. We used to lay out on a hill and he would point objects out to me that were flying. On a couple of occasions he said, 'Those are satellites. You can tell because they are moving from east to west. Notice how they stay on a constant track?'

He said, 'Now here in a few minutes, we're going to see another light.' He pointed one out and said, 'That one is moving a little different.'

I said, 'Yeah, it's going different directions pretty quick.'

He said, 'That's right and that's not a satellite.'

I asked, 'What is it?'

He said, 'I can't discuss that with you. I just want you to know the difference and I want you to always remember this.'

I said, 'OK.' I was probably 12-years-old at that point.

DID HE SAY WHAT'S INSIDE THE ONES THAT DON'T MOVE IN A STRAIGHT LINE?

No, he never did. My mother told me she would tell me everything before she died. I was supposed to have a conversation with her on October 10, 1990. When I got to her house, I found her deceased on the floor.

YOU HAD TALKED WITH HER BY PHONE ABOUT HER GIVING YOU A DOWNLOAD?

Yes.

ANY OFFICIAL DETERMINATION ABOUT WHAT HAPPENED?

They determined that it was a massive heart attack.

DO YOU BELIEVE THAT?

No, not really. She was trying to get to the phone. She was half way between her room and the telephone. But that morning, I knew something was wrong. I woke up, sat straight up, tried calling her house and didn't get an answer. Jumped in my car and went right over.

DO YOU THINK YOUR FATHER TOLD HER EVERYTHING HE KNEW?

I think they were both involved.

Non-Human Implant?

COULD YOU NOW UNFOLD THE POSSIBLE NON-HUMAN HYBRID LINK YOU SUSPECT?

When I was around 8 and we did a lot of traveling with Boeing to different countries, Dad went on assignments – that's what he called them. He would be gone for six months to a year and come back. At one point, we were on Guam and Mom and Dad told me, 'We have to go somewhere today. You're not to talk about it.'

So, we went on to the airbase and went to an office where armed military police escorted me, my Mom and Dad to another building. We went inside. I remember the sign on the door said something like 'Armed Forces Intelligence Agency,' or something like that.

Dad went in and then they called Mom in and then they both came out and Mom told me I had a doctor's appointment. We went to the doctor's appointment, a Naval doctor, and he examined me, ran some blood work and other tests. Then he said I had a tumor in my brain that needed to be removed and they were going to do a new procedure where they would not have to cut me from the outside. They would go in through my nasal cavity and as the doctor explained it, 'Cut the object into four pieces and bring it out through my nasal cavity.'

I was pretty scared at that age of around 14 when I went into surgery. I remember bright lights. I have a really foggy memory, but it almost seemed like the same people were there that were in my bedroom (when I was 8).

THE BLONDS?

Right.

WERE YOUR PARENTS BLOND AND BLUE-EYED?

No, my Dad had darker hair, kind of bald in the middle and a Caesar cut. He had hazel eyes. My Mom had dishwater blond hair and blue eyes.

Anyway, I came out of surgery and everything was fine. They said they got what they went after. I was in the Naval Hospital on Guam.

WERE YOU IN A NAVAL HOSPITAL BECAUSE YOUR FATHER WAS WORKING FOR THE NAVY?

No, my Dad was supposedly a civilian contractor, so by all rights, I should have been in Guam Memorial Hospital.

DID THAT PROVE THEN THAT YOUR FATHER ACTUALLY WORKED FOR THE MILITARY? OR MILITARY INTELLIGENCE?

I later found out that even though he worked for Boeing, he also worked for the Army's Counter Intelligence Corps (CIC) and apparently did some back-engineering of some type.

ON NON-HUMAN TECHNOLOGY?

Reverse engineering it, yes.

IS IT ALSO POSSIBLE THAT HE WORKED FOR THE U. S. NAVY?

Could have been, but the Navy doctor was flown in.

JUST TO DO YOUR SURGERY?

Yes, when I was 14.

WHAT DID YOUR MOM AND DAD SAY TO YOU AFTER THE SURGERY?

That it went really well and should never grow back and they got the object they were going for, the tumor. I had packing in my nose. When I looked in the mirror, I only had two or three stitches. I was looking in the mirror trying to see where they did the cutting. There was a very clean cut.

WHAT DID YOUR DAD SAY?

He just kind of grinned and said, 'Everything went fine.'

A week later I had to go get the packing taken out at the Guam Memorial Hospital. The same doctor was there. He said there was about 25 yards of packing in there. He said it was going to sound like a freight train when he took it out. There was a little piece hanging outside my nose. He grabbed it and started pulling. It seemed like forever before the end came out, but that was an experience!

AT ANY POINT BEFORE YOUR MOM AND DAD DIED, DID YOU TALK WITH EITHER OF THEM FRANKLY ABOUT THEM REMOVING A NON-HUMAN IMPLANT UP IN YOUR SINUS CAVITY?

No, they always referred to it as a tumor. The paper work I have said I was operated on at Guam Memorial Hospital and they removed a tumor from the frontal lobe by going through the sinus cavity using the Caldwell-Luc procedure.

DO YOU THINK AN IMPLANT WAS REMOVED THAT THE BLOND BEINGS PUT IN WHEN YOU WERE 8?

Yes, I do, because I do remember the doctor telling my Dad that they sent it off for tests to Bethesda Naval Hospital.

U. S. Military Collaboration with Non-Humans?

WHEN DID IT DAWN ON YOU FOR THE FIRST TIME THAT YOUR FATHER WAS WORKING WITH THINGS NON-HUMAN AND YOU MIGHT HAVE BEEN TAKEN FOR RESEARCH?

I always felt different. One night I heard my Dad talking with some people he worked with – I wasn't supposed to be up listening. But I heard someone ask Dad how I was coming along and one of them asked, 'Does he know anything about what's going on?' Dad said, 'No.'

When I asked him about hearing from a friend of one of Dad's friends that I was adopted, he told me, 'No, you're not adopted. We're your real Mom and Dad.'

SO, HOW DO YOU PUT THAT ALL TOGETHER?

My Mom had me when she was 43 when she got pregnant with me, which had the doctors concerned. But there were no problems with the pregnancy. So, I wonder if my Mom was my real birth mom? Or someone else was my father?

OR YOU WERE AN IMPLANTED FOETUS?

Yes, that's what I was trying to say.

DID YOUR FATHER EVER, BEFORE HE DIED, ACKNOWLEDGE THE TYPE OF NON-HUMANS THE GOVERNMENT HAS BEEN WORKING WITH? AND WHO WE'RE TRYING TO FIGHT IN AN EARTH'S SECRET WAR?

No. He never would. I would bring up the subjects of UFOs when I got older and he just refused to talk about it.

Non-Humans Teaching Symbol Language

SO, WHEN DID YOU COME INTO THE KNOWLEDGE ABOUT THE SYMBOLS?

That started after my Dad passed away.

WHICH WAS?


November 9, 1980. (27 years ago)

SO, 27 YEARS AGO FOR THE FIRST TIME IN YOUR LIFE, WHAT HAPPENED?

On several occasions I saw craft, like one that followed me for an hour.

SHAPE AND COLOR?

Two silver spheres. It was night time, so they were a blue-white glow with a cylindrical attachment between the two spheres. I was driving home from a date. We noticed them at the light. We were out with a couple of other couples. One of the girls saw them. They kept dipping down close to the lake. For some reason, all the kids were scared. We took off. The other two couples rode together and went down to one of their parents' houses. My date wanted me to take her home to Andover, Kansas.

On my way to Andover, I could see the lights. The spheres would separate. The cylindrical object would pretty much stay in place, but the two balls would separate and dance around. Then they would connect again. Dropped her off in Andover and then for the next 45 minutes all the way to my house, it followed me. I got to the house and got out of my car. It stopped over my house for a few seconds. Then in a matter of less than a second, it was gone and out of sight – straight up!

I told my Dad about it the next day and he said, 'Oh, that's nothing to worry about. Those kinds of anomalies happen. You're going to see them from time to time. But don't worry about them.'

INTUITIVELY, WHAT DO YOU THINK? WAS IT TRACKING YOU TO YOUR HOUSE?

I think they always knew where I lived. I think they were checking in.

BUT FOR WHAT REASON?

I don't know.

THAT WAS WHAT YEAR?

That would have been around 1976.

THIS IS BEFORE YOUR DAD PASSED?

Yes.

WHAT IS THE NEXT EVENT THAT BEGINS TO FOCUS IN YOUR MIND THAT YOU ARE DEALING WITH NON-HUMANS AND THEY ARE INTERESTED IN YOU?

That happened around 1981. I was asleep and I woke up and there was this kind of mist around.


COLOR?

White mist, just kind of hovering over the top of me. I got up.

WHEN YOU GOT UP, DID THE MIST STAY AROUND YOU? OR DID THE MIST HANG OVER WHERE YOU HAD BEEN IN BED?

When I woke up it was just over me and when I got up, it just kind of dissipated. And I was tired!

Hooded Figure Pointed At Symbols

Then a couple of nights later is when I was asleep and the next thing I remember is I was sitting in a concave chair. There's an entity of some sort sitting to my left. Kind of a darkened room, but it's lit – but not like with a light bulb. Then the next thing I know is these panels start spinning – one to the right and one to the left. The panels would stop spinning and a symbol would light up. Then a hooded being would point at the lighted symbol.

YOU ARE SEATED IN FRONT OF THE TWO PANELS OF SYMBOLS. THE UPPER SYMBOLS ARE MOVING ONE DIRECTION AND THE LOWER SYMBOLS ARE MOVING ANOTHER DIRECTION.

Right.

WHEN THE PANELS STOP SPINNING IN OPPOSITE DIRECTIONS, ONE SYMBOL LIGHTS UP AND THE HOODED BEING POINTS WITH WHAT AT THE SYMBOL?

With its hand.

WHAT DOES THE HAND LOOK LIKE?

I can see an index finger – I could only see 3 fingers, kind of like human, except the fingers were longer.

COLOR?

Kind of dimly lit, but kind of a pale blue color, almost a grey color.

GREY-BLUE COLOR. THREE LONG FINGERS. WERE THEY EXTENDING OUT OF A BELL-SHAPED SLEEVE? OR WHAT?

As I remember, it was sort of a bell-shaped sleeve, but not a dramatic bell.

THE HOOD WAS COVERING WHAT KIND OF FACE?

I never got a good look at the face. I got the feeling that he was moving the panels with his mind because he kept staring at the wall. I was in a completely round room and the symbols were all the way around.

DOUBLE ROWS OF SYMBOLS WENT AROUND THE ENTIRE CIRCULAR ROOM?

Right. I could see them, but I could not make out definite shapes until they came around and it was almost like they were lit up from behind.

DID YOU HAVE TELEPATHIC COMMUNICATION WITH THE HOODED FIGURE ABOUT EACH OF THE SYMBOLS THAT STOPPED AND IT POINTED AT?

Yes.

WHAT WAS THAT TELEPATHIC COMMUNICATION?

'You need to remember this.'

WHAT COMES INTO YOUR MIND ABOUT WHAT YOU NEED TO REMEMBER?

I don't know, except it was important for me to remember, almost like I'm going to see it again and when I do, it will all come together then. But right now, it's just memories of symbols. Important symbols. But I don't have any correlation of what they mean right now.

Blonds, Greys, Lizards and Big-Nosed: What Is Their Relationship?

DO YOU THINK THE BLONDS ARE DOING ONE THING WITH YOU AND GREY BEINGS ARE DOING ANOTHER?

That I don't know. I think I have been contacted by both.

WHY WOULD THE BLONDS HAVE TO BE INSIDE A CLOAK?

Right, the two times I've seen them, they've not been hooded.

WHEN WAS THE NEXT DATE OF ENCOUNTER WITH THE BLUE-EYED BLONDS?

That would have been not too long after – like in surgery, I could almost smell they were there.

THAT WAS AGE 14.

Then we spent 4.5 years on Guam. Then I was on a camp out with the scouts. We were up on a mountain close to the WWII battleground, camping out. I had a little tent of my own. I woke up and a blond being was on each side of me. One female and one male again. I remember that the male had some kind of device and the female – because that's what woke me up – she had her hand on my forehead. Then again, she gave me that same smile and I got the feeling they were the same two in my room when I was 8. I was told again not to worry, that I would be watched over. That's the last time I saw them.

WERE THEY DRESSED IN THE SAME METALLIC SILVER SUITS?

It was a metallic suit, but it looked different that time. The suit looked pretty much the way it fit, but it looked like there was a collar with an emblem on each side.

WHAT DID IT LOOK LIKE?

Shiny.

SHAPE?

Reminded me of like a triangle, with something real silver and bright in the center. The symbol itself was shiny, but the dot in the center was shinier.

THERE WERE TWO METAL TRIANGLES, ONE ON EACH SIDE OF THE COLLAR ON EACH ENTITY?

Right.

ANY SYMBOLS ON THE SUITS?

It looked like there might have been something there, almost like a breast plate.

HOW OLD WERE YOU THEN?

I must have been 16.

SINCE AGE 16 ON GUAM, YOU HAVE NEVER HAD ANOTHER MEMORABLE ENCOUNTER WITH THE BLOND NON-HUMANS?

Right.

WHEN IS YOUR NEXT ENCOUNTER WITH ANYTHNG NON-HUMAN?

That would be in the ship with the symbols.

AND YOU DON'T KNOW IF THE BEING WAS BLOND OR GREY?

Right.

AND THAT WAS IN 1980 TO 1981?

Yes, around then. Then I was shown the symbols again around 1991 to 1992 by the same hooded figure.

BUT STILL NO CLARITY?

No, not of what was inside the hood.


HAVE YOU HAD A CONSCIOUS FACE-TO-FACE ENCOUNTER WITH THE GREYS?

No, not that I'm aware of.

Underground Invasion by Big-Nosed, Cat-Eyed Greys?

HAVE YOU HAD A FACE-TO-FACE ENCOUNTER WITH LIZARDS?

With something that wore a suit also, but resembled a lizard or crocodile standing up.

WHAT YEAR, WHAT TIME, WHAT WERE YOU DOING?

That was probably about 1993 to 1994. That's when I was shown – and I don't know if it was a future event or what – but I was shown basically an invasion and that we were being harvested as workers. And they were taking over some kind of underground – I don't know if it was a mining operation. I don't know what it was.

WHO IS THE 'THEY?'
