

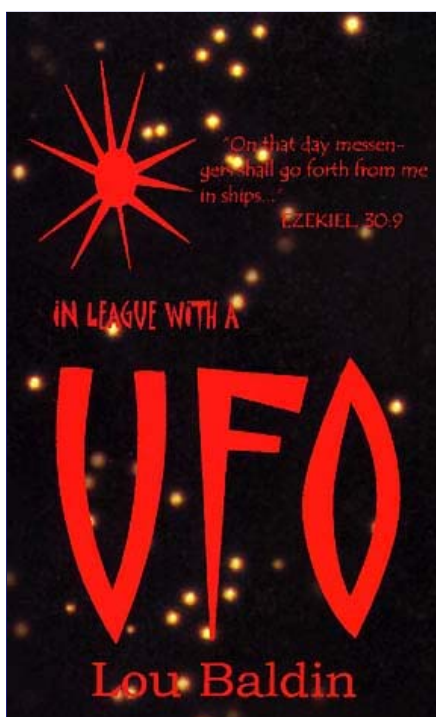


Part 10: In League With A UFO

December 22, 2007 Albuquerque, New Mexico - Chapter 7, The Second Encounter continued.

Bill Smith (not real name of committee member and human abductee) advanced to where he was allowed to roam freely aboard the craft.
