# **Part 2: Non-Human Entities (NHEs): One View from Alleged Government Insiders**

June 21, 2009 Albuquerque, New Mexico - After receiving the Writers' first floppy disc communication to me dated June 21, 1994, I submitted my questions and comments on June 16, 1994.

July 16, 1994

Dear Writers:

Have been reading Bohm and will get the other books. Michael Talbot's *The Holographic Universe* summarized Bohm's direction for a lay audience. What people did not know is that he was affected by the "abduction syndrome" and the investigator on his case said the entire book grew out of Talbot's interaction with whatever intelligence was behind the abduction events.

Mind control is clearly a part of the abduction phenomenon and was evident in the earliest cases. But many abductees insist the mind control is produced by advanced technology, especially the use of sound frequencies. In the June 1994 issue of Discover Magazine on pages 89-98, there is an article entitled "Quantum Consciousness" about the work of Roger Penrose and Stuart Hameroff. The crux of the work relates to the discovery of microtubule networks in the cells of brain tissue which actively transmit vibrational signals and resonate with each other.

- 1) Are those microtubule networks the key to the NHE's easy ability to use sound frequencies to control and/or monitor humans and to "take out minds," as the abductees say?
- 2) Was MKULTRA actually an effort to develop a counter-offense against the NHE mind
- 3) Is there any successful counter-offense to NHE mind control?

Back in 1983, I was told that the SDI program begun publicly with congressionally allocated funding during the Reagan administration had nothing to do with the Soviets, but that its real goal was to "fight off" an enemy from space. Others have come to me demanding anonymity and have made references to "Earth's secret war," but without providing specific details or hard evidence to back up their allegations.

- 4) Do you have hard evidence that there is a "secret war" being conducted by the U. S. government against NHEs? If so, could I see such evidence confidentially and for background understanding only?
- 5) If there is such a war, why would the U. S. government feel confident it could succeed against another intelligence that I understand is millions of years beyond us humans?
- 6) Is there an ally that is also non-human that supports the U.S. efforts? Edward Teller was obsessed, perhaps still is, with pushing forward the SDI program (now the Ballistic Missile Defense Office) against all congressional efforts to stop it. Is his obsession related to his knowledge about the alleged "secret war?"
- 7) Is the real mission of the BMDO Clementine Project to the moon and 1620 Geographis related to the "secret war?" If so, how specifically?

One contact of mine told me that not all moving lights were hard physical objects, but "tears in the electromagnetic membrane between universes or dimensions. said that non-human entities from some other dimension have come into this universe/dimension from an unimaginable place through tears in the electromagnetic membrane. That contact implied that we enlarged the "tears" during the 140s with our atomic and hydrogen bomb testing.

8) Could you specify in detail what is accurate about the above statements and if anything is not accurate? Do you have factual knowledge that Oppenheimer was abducted from Los Alamos in the early months of scouting locations for the Manhattan Project?

The same contact told me that Oppenheimer was the first known human abductee and was told that splitting the atom would cause damage in other dimensions of which we were unaware and that the Truman Administration's development of the bomb must stop.

- 9) But the Truman Administration proceeded with the Manhattan Project. Why wouldn't the "abducting intelligence" simply have stopped all bomb development if it were truly a problem for them, or for someone else?
- 10) If there is any truth to the above statements, what is the motive for NHEs described as neither benign nor neutral to come from another dimension into this one?
- 11) Is it true that Homo sapiens sapiens and prior humanoid species were created from DNA manipulation by some advanced intelligence in order to have sophisticated biological androids "work the earth" for them?
- 12) If so, as Fort said, then humans are someone's property. If so, are the NHEs you are concerned about in conflict with the human race's creators?
- 13) Or are the NHEs you are concerned about responsible for the creation of humans on this planet?
- 14) Why would another dimensional intelligence want a toe-hold in this universe in the first place?
- 15) Or as the Gnostics suggested centuries ago, is our entire universe a hostile NHE creation via the alleged Luciferian Fallen Angel rebellion and that anyone in this universe with a soul is God's way of pulling the rug out from under the hostile, rebelling NHEs?
- 16) If there is a battle for souls in this universe, are there "human bodies" among us on the earth now that do not have souls? Do the NHEs have souls?
- 17) If the "recycling of souls is the machinery of the universe," as one alleged intelligence agent told me, is the definition of Satan anything outside that process of soul recycling to and from the Light?


One contact told me in 1983 that a truer picture of cosmology is:
