A Message from your Director

Congratulations are extended to the UFO Study Group of Greater St. Louis as the host organization for the Second Annual Midwest UFO Conference and a very successful meeting. It was professionally engineered from the beginning to end with all the minute details properly adhered to. This Conference set the stage and pattern for all future affairs and will present a real challenge to subsequent host organizations. For fear of omitting one name in the list of people deserving our vote of appreciation, the members of MUFON express their thanks for a job well done to every Committee Chairman, Committee member, their spouses, and each of the speakers.

The Annual Meeting of the Mid-west UFO Network will be held each year in conjunction with the Annual Conference when the greatest participation could be expected due to travel distances and times. The Annual Meeting was held Sunday, June 13, 1971 from 10 am to 12 noon

at the Holiday Inn - North, in St. Louis, Mo. with twenty-seven voting members present. Clarence O. Dargie was the recording Secretary, with your Director presiding. A brochure covering proposed goals, objectives, organizational structure, operating policies, and philosophy of MUFON was distributed to each member for their evaluation and discussion prior to writing the By-Laws for application as a "Not-for-Profit Corporation." Revisions were suggested and approved.

Since one of the major policies of MUFON is to share UFO informations with its members and other cooperative organizations, all Annual Meetings will be "open to the public." However, voting privileges must be reserved to individuals holding valid membership cards. Membership cards had been distributed to those qualifying as of this date. It was again stressed, that membership in MUFON is by invitation only. Formal membership applications with membership cards will be mailed to members unable to be present. Each should return the completed form to your Director, so that we may have a comprehensive view of our members' qualifications and talents.

The organizational chart of MUFON has become so complex and cumbersome due to continued expansion, that individual pages will be set up for each State organization and revised accordingly to keep them current.

UFO Sighting Reports, Form 1 and Form 2 were distributed with a written explanation concerning their use. It was agreed that the narrative description of the sighting was as important as answering the suggested list of questions and check points on the two forms. The responsibility for determining whether the report is creditable, authentic and suitable for publication in SKYLOOK rests with the Field (Continued on next Page)

Amounts proposed for a "Life-time membership" varied from three to five dollars on a "onetime basis." Subscription to SKYLOOK is entirely independent of membership in MUFON. However, we sincerely encourage all members to subscribe to our official publication.

Plans and a schematic diagram of the UFO magnetic detector demonstrated by William H. Hunkins of Coralville, Iowa at the Conference will be reproduced and distributed to members seeking this informa-

tion from your Director and via SKYLOOK.

It was suggested and agreed upon that each local UFO study group would place copies of the 1971 Conference Proceedings in libraries in their immediate area of influence at their own expense as a Civic contribution.

The consensus of the members present was that the Midwest UFO Network is a regional and not an International organization, therefore we will confine the majority of our activities in an area of the United States from the Appalachian Mountains in the east, the Rocky. Mountains (Continental Divide) in the west, Canadian border to the north, and south to the Gula of Mexico and the Mexican border, en-

compassing twenty-five States.

Conference Notes With the Conference program printed in previous issues of SKYLOOK (and see page ad for the book "Complete Conference Proceedings of the 1971 Midwest UFO Conference), we will not repeat here,

but will put tegether some comments and bits and pieces of relevant "news" from letters received since June 12th.

First of all, it was a big success. Attendance figures reaching us range from estimates of 700 to 1100. Morning, afternoon and evening sessions were all well attended and more than one hundred attended the evening banquet at the Holiday Inn, North, St. Louis.

We received one of the clever "flying saucers" made by Carol Armstrong and gracing the banquet tables; and while it didn't arrive on its own power, it looks as if it could take off at any time, and we're keeping an eye on it.

Ted Phillips, of Sedalia, and our only staff member we see in person very often, stopped by last week and was enthusiastic in his praise of the Conference, and he has some fine ideas for the next one. Being modest, Ted said little about his own part in the speaking program; but others have written us his talk on "Landing Traces" was one of the most interesting -- evidently the TV representative thought so too. for he invited Mr. Phillips to appear on a St. Louis TV program, and he did so.
Stanton T. Friedman, the featured speaker, was extremely well re-

ceived and his positive attitude on the subject of UFOs creates new interest where ever he is heard.

The Conference was well advertised. MUFON members were invited to appear on radio and TV and good press notices appeared in the newspapers of the area. In a letter to "Physics Today" (June 21, 1971) Dr. J. Allen Hynek (his name is all the introduction needed) writes: "In order that material of potential scientific value not be lost, and in order that persons, particularly those with scientific training and experience, can submit a UFO report without feer of ridicule and publicity, my colleagues and I, all associated with universities, hereby offer to act as a receipt center for UFO reports that otherwise would almost certainly be lost to science. I will be personally responsible that the data so submitted will be treated seriously and that no embarrassment to the sender will result. Names, for instance, will be immediately disassociated from the report and not used without specific written permission of the originator.

He writes: "I - have had a deep interest in the UFO phenomenon for the past six years and in the past year I have begun to specialize in e finding out what has happened behind the Iron Curtain concerning UFO sightings and the research being done there. I have been able to secure material from Russia, Bulgaria, Czechoslovakia, Yugoslavia, Ecmania and I am presently attempting to obtain material from Poland and Hungary. I have been greatly surprised to find out there has been a great number of sightings in the Soviet Union and the eastern European countries es well as several books published in these countries on the subject of UFO's. As of this date I have never observed a UFO, but I have absolutely no doub t they exist."

The first article of the series is out of Bucharest and written by Ion Corvin Singeorgan, Director of the Popular Astronomical Observatory of Bucharest, Romania. The date is Oct. 12, 1968.

RLYING SAUCERS -- A PHENOMENON WITH RATIONAL ACTIVITY UFO'S OBSERVED AT DIFFERENT HOURS

If in fact, UFO's really exist, this fact does not tend to surprise us anymore at present. The uncomfortable conclusion after which the 'flying saucers' constitutes a phenomenon with rational activity, most

naturally raises serious thoughts.

As it is well known this conclusion leads us to two types of hypothesis regarding the nature of this phenomenon: the terrestrial hypothesis and the extraterrestrial hypothesis. It may seem that after the statements publicized regarding the American reports, that the balance leans toward the extraterrestrial hypothesis. However, it would be premature to completely rule out the terrestrial hypothesis. But, even the point of view quite frequent after which the lands of this planet would or could not be responsible for producing the mysterious UFO is does not lack in hardships. From where would come rational beingswhich direct the UFO's or more exactly where is their original planet? Judging from the knowledge we have regarding life on earth, and the physical, chemical and biological conditions existing on the planets of our own solar system, it is very difficult for astronomers to imagine thoughtful (intelligent) beings and civilizations on any of the neighboring planets with land surface. And then , not finding them in our own solar system his thoughts fly to a distance of at least a few light years. Some place on some hidden planet in the system of another star. Proxima Centauri, Sirius the known stars neighboring the sun form a triple system and the second one a double system of stars; in the conditions of the complex orbit of a planet around these systems, it would be very difficult for a civilization similar to the one we have here on this planet, to develope. But other, close, less famous stars

maintain their attention. Such as the star Barnard, (6.2 light years) the star Lalende 21185, the star Wolf 359 ect. the last two at 8 light years distance. Systems with a single sun, which from this point of view might offer the necessary conditions. However, from other points of view (for example the

UFO's Behind the Iron Curtain (Continued) Annual was a still of the age of the system) the conditions for a civilized planet would be more or less favorable, but the existance of a civilization of the terrestrial type on these planets of such systems is not completely ruled out,

Nor is the way to earth from those planets. Fantastic for some beings with a technical knowledge relatively superior to that of earthly beings We can imagine the sidereal trip of the extra-solar beings, comparing it approximately of course, with the trip of the heroes of the motion picture "The Planet of Apes." Evidently, the distances between civilizations for actual communication possibilities are practicly infinite. They would however be considerably reduced if we admitted the hypothesis of those men of science who consider that it could be possible in reality for some forms of life to build on other bio-chemical foundations of life, other than the terrestrial carbon compounds and some imagine the possibility of the appearance and the developing of life in the universe on the basis of silicon-organic compounds of an ammonia enviroment, ect. Wouldn't it then be possible to dwell on some gigantic planet of our own solar system, Jupiter or Saturn for example. in this case couldn't the UFO's come not from light years away, but from millions of miles, perhaps from a super-civilization of the solar system.

If we suppose that it would be the result of the rational activity of some extraterrestrial beings? And so, communications even on earth in this case between us and our cosmic quests would probably be slowed down because of the incoincidence of the domains in which our feelings are sensible compared to theirs. Risky questions and thoughts which seem to be suffering of the fantastic, but which sooner or later will have to be asked.

UFO Follows Car in Buhl, Idaho

The frightened witness climbed Clear Lakes grade and saw it again. The UFO, about 20-30 feet long and 15 feet tall, passed over the car at tree-top height and disappeared.

U.F.O. Huger UFO Sighted Near Carlyle Lake R E P O R T S The following report by Terry Turner appeared in the "Breese Journal," Breese, Ill: -- Two Beckemeyer men sighted a very large UFO near the Carlyle Lake at a-

bout 10 p.m. Tuesday evening, May 11.

Jerrel Garner and a friend, who chooses to remain anonymous, were about two-miles north of Carlyle, traveling south on Rt. 127 when they first observed the object. Mr. Garner, who was driving the car; saw what appeared to be a very bright light that was obscured by the clouds which were hanging over the lake at the time. At about the same timehe first saw the light, it brightened considerably and emerged from the cloud cover. As well and a strong off

Toud cover. As a second slightly larger than the full moon. It was shaped like a perfect semi-

circle and was bright orange in colonia

cle and was bright orange in color; and a second towards carlyle, they as Mr. Garner and his friend continued driving towards carlyle, they noticed that the light, which was at first stationary, was pacing their automobile. (Mr. Garner estimated he was driving approximately 50 mph.) The strange light followed the men into Carlyle, remaining at a constant distance from their vehicle the entire time. The men estimated that the object was roughly a thousand feet east of them and at an altitude of approximately atthousand feet was the

When the men reached the southeast side of Carlyle, they were forced to stop the car when they came upon a dead-end-road. At the same instant they stopped the UFO elso stopped and slowly faded from its previous brilliance into total darkness. The men remained in the area for

a few more minutes but were unable to sight the object again.

At the time of the sighting the sky was extremely dark and cloudy. Neither the moon non the stars were visible. Both Mr. Garner and his companion were convinced that the brilliant silent light which passed their car was no conventional aircraft. They both agreed that it was definitely a UFO. Blue Cigar-Shaped Object in Texas and actions to the contract to

"Cross Country News" is an aviation newspaper published at Meacham Field, Ft. Worth, Texas. Its editor, Tony Page, is interested in UFO's and now and the n includes an item on unidentified flying objects in her column "Tony's Page". The following report is from the April 22, 1971, issue, rewritten by Ye Ed to meet space requirements.

Robert Rozelle a student who works days for a large department, store chain in the Et. Worth area, was on his way home from class one night. in February, about 9:55 pm. when he saw a bluish kind of light, rising off to the southeast. He was driving west at the time, and stopped along side the road to watch the object for about fifteen minutes.

He described it as sort of slanted oblong "cigar shaped" close to the ground. It was bright and huge. It seemed to be rising in a "float-

ing" motion suntils it to took soff sins a controlled direction.

- Rozelle said there was very little street traffic. Sound from the object was very faint . The object appeared to be 300 feet long, or longer. When it moved, it changed to an almost verticle attitude "like a cigar standing on end."; The standing of end. "When it took off to the northwest, at a sharp angle, it moved fast-

er than anything I have even seen; "he said. "It was just gone.

Later the sighting was pin-pointed to have been near the Quartermesters Depot in S-Tarrent County : His sighting was confirmed by two. other students in his class, returning home the same night, same time, and the reporter getting the story knows they are not the "kooky" kind of student protrayed by "some TV and some national press people." The cigar-shaped object was blue, with bands running down the side, giving off occasional flashes of vellow light, Rozelle said. There was no off-on rhythem, to the flashes, but it looked like passages or doors being opened irregularly. The object was smooth, no bumps, knobs or nodules. After being watched fifteen minutes, the object rose in:

leisurely fashion, stopped, then made a sharp right angle turn, up at a 45 degree angle and was out of sight in about 15 to 20 seconds.

UFO in Massachusetts

Warren L. McCarthy of 1 Bell St., Spencer, Mass., sighted a UFO between 4 and 4:30 on May 29, 1971. Hartford (Conn.) WATCHMAN; Jan. 28, 1837.--BRILLIANT APPEARANCE IN THE HEAVENS--On the evening of the 25th inst. between seven and eight o'clock, the portion of the sky most easily seen by a spectator looking upwards was splendidly illuminated. At first the rays of light were of a deep orange color, approaching to redness, and seemed to converge from the North, East and West of North to a common centre in the zenith. The rays, at different points, were condensed into solid bodies, some of greater and some of less density. They gradually moved from North to South until the zenith was reached, and from this as a centre of radiation extended downwards in all directions; till the appearance became in a high degree splendid. The rays and bodies of light, of the deep orange, were beautifully intermixed with those of more than a cream color whiteness. For some minutes, a spectator would readily believe that he was beholding a vast umbrella, its covering varying in thickness and in shade, now dense, now rare, in spots brilliant, in others gleaming with pale light. The lighter and deeper shades seemed at length to commingle, and be lost in an appearance not unlike that of the common Aurora Borealis. At the point of greatest illumination the light was sufficient to cast a distinct shadow. The whole gradually moved to the South and vanished. The appearance in form was unlike any of the same sublime phenomena which we have before witnessed. At a quarter past ten o'clock, the phenomenon was again visible and with increased brilliance. At each time of its appearance the main + bodies of light, rising from points East and West of North, were so brilliant as to excite in many minds the apprehension of a great fire. In the second instance the color was of a deeper hue, and the whole seemed to observe the same laws of motion and radiation, and assume the same form as in the first, and for a time to be nearly stationary at the zenith. It is said the luminous appearance was observed again at midnight, and again at three o'clock in the morning. We had not the pleasure of seeing it at either of these hours.

Carlyle Man Sight's Three UFO's again the of the same of the same

Herb Williams, a Carlyle, Ill., truck driver and employee of the Illinois Revenue Department, has had three separate sightings of UFO's within the last month. His first experience with a UFO occurred on the night of April 30th at the Ready Mix station in Carlyle. This was given in the June issue of SKYLOOK, and we will not repeat.

Three nights later at about 9:30 p.m. Williams was driving his truck west on Illinois Rt. 177 between New Memphis and Mascoutah. It was quite natural that he was watching the sky more closely than usual. It was a clear night and the moon and stars were visible. Suddenly, Williams noticed a bright, white light, brighter than a star, that did not conform with the other celestial objects in the night sky. It was close to the ground, about 200 feet high, traveling slowly in an easterly direction along the line of the railroad tracks. It was also silent as far as Williams could ascertain.

The object soon passed from his view since they were traveling in opposite directions. Notice the remarkable similarity between this UFO and the one previously sighted by Mr. Williams. tracks at very low altitude. Is this merely coincidence or were bothobjects performing a similar function which required slow low alti-tude travel?

The following night Williams was again driving on Rt. 177. He and a friend were in the vicinity of Covington heading west, bound for Hoffman, when they noticed a bright light off to the left of the road at at altitude of about 5000 feet. It was moving southeast to northwest and descending at the same time. At this time Williams pulled his truck of the road and parked so that he and his companion could observe the object more closely. The UFO also stopped and remained stationary in the air about 500 feet above the ground.

The UFO appeared as a brilliant, white light -- as bright as an aircraft landing light and roughly the size of a dime held at arms length. After the men had observed the object for about two minutes it suddenly accelerated at tremendous speed and moved to a position about 3/4 of a mile north of the observers where it again assumed a stationary position. The men noticed that when the object accelerated it emitted a long, reddish streak--like an exhaust stream.

After entering their truck and continuing their journey, the men observed the light about 30 minutes later, still stationary and in ... roughly the same position. It then disappeared from view, At the time of the sighting, the sky was clear and there were no conventional aircraft nearby.

Ten of them are in fixed positions but capable of being turned to face in any direction, while two are movable along 300 yards of rail track. With this awesome radio telescope at Westerbork in northeastern Holland, they plan in-tensive studies of the nuclei of distant galaxies with the goal of helping establish the structure and evolution of the universe.

This bright red sky object could generate a number of UFO reports.

The Constellations. No. 8. Scorpius (the Scorpion).

The Egyptians, the Arabs and their predecessors all show the image. of a Scorpion in their early pictures of this part of the sky. The sharply curved formation of stars that makes the tail of the Scorpion does look like the tail of one. It is easier to see a scorpion in the constellation that it is to see in most of the constellations the things or animals for which they are named. Long ago, the western boundary of Scorpius was extended to include the constellation of Libra. The two bright stars in Libra bear names which mean the Northern and

Southern Claw (of the Scorpion).

Scorpius is striking and should be identified without too much difficulty. The great red supergiant Antates, glowing like a furnace in the southern horizon, should mark it beyond question. Antares is one of the largest stars known. It is about 1000 times the Sun's diameter. If the sun were placed at the center of Antares, all the planets almost to Jupiter would be buried inside the vast star. Antares means "The Rival of Mars." Both the star and the planet are unmistakably red, and since Antares lies very near the ecliptic and the path of the planets, Mars is occasionally found in its neighborhood. The main stream of the Milky Way, just below the hub of the local Galaxy, runs wide through practically all of Scorpius. It brings with it a great number of bright stars and many clusters and nebulae.

an accuracy which seems impossible in documents so old.

The maps were examined in 1952 by Arlington H. Mallery, an American cartographer. He discovered that they are detailed and accurate, not only in depicting the Mediterranean and Middle East areas but North and South America, and even the contours of the cantarctic.

The ancient maps correctly trace the outlines of the continents and also show the topography of the interiors, including the Great Lakes of North America, mountain ranges, plateaus, islands and rivers!

Rev. Daniel Lineham, S. J., the Jesuit astronomer and director of the Weston Observatory, Boston, examined the mapsin 1967 and confirms that they accurately delineate geographical and topographical features presumably unknown to the ancient map makers.

Certain mountain ranges in Antarctica, officially discovered only in 1952 appear on the maps. How? That, of course, is the puzzler.

A photograph of the earth as seen from the Apollo 8 space craft shows a striking similarity to the Piri Reis map of the world. Prof. Charles Hapgood of the University of New Hampshire has suggested that a comparison of the maps with photographs of earth taken from space satellites indicates that the originals may have been taken from an enormous altitude.

Incredible? Yes, of course -- but then, so are many discoveries of modern science.

No less an authority than Carl Sagan of Cornell University, the astronomer who is considered one of the fathers of exobiology—the study of extraterrestrial life—speculates that ancient advanced civilizations, such as the Sumerian, may have been intellectually fertilized by spacemen.

Sagan, who says he has made no judgment about the authenticity of the Piri Reis maps, says it is a mathematical certainty, in his view, that the earth has been visited by space travelers in the past.

This is based, he said, simply on the staggering number of potentially habitable planets in the galaxy and the virtual certainty that some of them contain technological civilizations capable of crossing interstellar apace.

A Soviet astrophysicist, N. K. Agrest, thinks the earth shows traces of ancient scientific experiments. He cites tektites, mysterious glass-like stones, found in various parts of the world, which contain radioactive isotones of aluminum and beryllium. These, he speculates, are the remains of nuclear tests conducted by extraterrestrial visitors to earth.

Is it possible that the Pirit Reis maps are a relic of a visit from the stars in earth's remote, myths-shrouded past?

No More Twinkle? An Important Development.

The twinkle of a star is really the effect of the earth's atmosphere bending the starlight as it streams from the heavens. It's a lovely sight—but has caused astronomers no end of anguish because it blurs and sometimes totally masks the celestial object itself. Now three young scientists at the State University, Stony Brook, N. Y. have demonstrated a new way of de-twinkling stars by photographing them free from the distortion of the earth's shimmering envelope of air. In the April 1971 issues of SKYLOOK there is a report telling, of "Wo-man and Teen Age Sons Report Space Ship with Occupants" near Know City, Mo., Jan. 29, 1967--another UFO report of two occupants being seen inside a UFO. I have examined three UFO reports of this nature -- almost identical with minor differences.

with two occupants inside, one behind the other. They were standing in front of what looked like stools and they wore tight fitting suits. An instrument panel was visible inside. One occupant pushed a lever and the UFO circled in a counter clockwise direction. The UFO was silvery in color and shaped like a bowl. The top was a dome of a glass-like appearance. A string of bright lights circled it.

Case No. 2-Indiana, Pa., Jan. 24, 1968. The witness saw a round saucer-shaped object which had the appearance of dull aluminum. The top was transparent and the interior was clearly visible. Two occupants wearing coverall type clothing were inside. One of the occupants looked at the witness and the other ran over to a console and pushed two levers and the UFO disappeared.

Case No. 3-As reported in SKYLOOK (April 1971). On Jan. 29, 1967
Mrs. Campbell, of Knox City, Mo., and her two sons saw a sphere shaped object white in color "like a frosted light bulb." The object approached within two feet of the house. Around the center of the object was a thin ring "shiny gold" in color. The lower right quarter of the sphere was clear enough to show a control panel with a lever on top, and two occupants, one seated at the panel, the other standing-behind the first. The two seemed to be normal in every respect. They were wearing what looked like "shiny, silvery wet suits." The object hovered briefly before startint to ascend to the southeast.

Conclusion: In each case, two occupants were seen inside the UFO. In all three cases a console and lever or levers were seen. The occupants were wearing tight fitting, or coverall, type suits. The top of the UFO was transparent in each case, elthough in one it was "frosted." Case 1 mentions a string of lights around the UFO. Case 3 tells about a thin ring around the UFO. The three sightings occurred in a time space of three years (In case 2 the name of the witness is not known.) In Cases 1 and 3 the sightings were made by apparently intelligent observers who described in detail what they had seen.

Could one assume the three sightings were of the same UFO and occupants, seen in different locations and at different times? The slight difference in color of the UFOs and other minor deviations could be due to the observers seeing them in a different light or angle.

The first hint that an ESP experiment might be in the unofficial schedule for the Apollo 14 program came in an interview with astroenaut Mitchell ("Chicago Daily News," January 30). Mitchell was characterized as the most intellectual of the astronauts and as an "amateurr star gazer with a fascination for psychic phenomena." The article told of Mitchell's "insatiable appetite for exploring psycho mysteries," and the astronaut admitted that his interest in psychic matters often interrupted the few hours the space program had allotted him to spend with his family. Mitchell said that he could find no conflict between his curiosity for the unknown and the computers of Apollo 14. "I am completely unable to separate science from theology, from art, from humanity," he said. "Man is a total thing; everything is a total thing."

What had not yet been released was the fact that several months before the Apollo mission, Mitchell had asked a select group of parapsychologists to find a sensitive subject for an experiment across a quarter of a million miles of space. The sensitive the doctors chose ジーセーウザ かどうここは was Chicago drafting engineer Olof Jonsson.

About two weeks before blast-off, Mitchell and Jonsson conducted a number of telephone experiments with the symbols of a standard ESP-"testing deck in order to gain rapport." Jonsson says that these early tests were successful. Astronaut Shepard may have carried a golf club on board the space capsule, but Mitchell brought a pack of ESP cards along with him.

On February 3, Earth News Service of San Francisco broke the story of the telepathy tests. They quoted an insider who said that the test had been stimulated by "numerous reports of similar experiments in telepathy being conducted by Russian astronauts." A NASA spokesman officially denied that such tests were being carried out on the Apoltio 14 mission, but during the astronauts "splash down on February 9th, " CBS news announced that while Mitchell had been in space, he had conducted some ESP experiments with a Chicago engineer.

On February 13, the wire services released Olof Jonsson's name and newspapers throughout the world carried details of the experiment. The release, date-lined Houston Space Center, emphasized that the experiment had been a personal project of Mitchell's, which had in no way infringed upon his assigned duties.

According to LIFE (February 26), Mitchell had, in deference to

NASA, conducted the experiments during his rest periods. In all, he and Jonsson had completed six experiments of six minutes each, one on each of the three days before and after the moon landing. Jonsson sent his record of the experiments to the group of screening scientists, who will compare the two men's reports. Mas of this time, astronaut Mitchell has indicated to newsmen that he will release the results of the telepathic tests in what he considers "the proper time and the proper scientific journals."

Editor's Note: The June issue of ARGOSY has an article on this ESP experiment, but does NOT have the results -- contrary to the inference of the title.

POST, now on the stands, has an article on UFOs by noted science/science-fiction writer, Arthur C. Clarke. Unfortunately, the magazine has not appeared on any of the local stands, so it is impossible to review it here. Although Mr. Clarke has not been a foremost proponent of UFO reality in the past, it would doubtless be interesting to see what he has to say at this time. I we couldn't find a copy of the S. E. The July issue of SAGA contains additional excerpts from Ivan T. Sanderson's book, INVISIBLE RESIDENTS, which we will review below.

YES! by Saunders & Harkins (book number 3394) for only \$1.00 each. PCB has Jay David's FLYING SAUCERS HAVE ARRIVED! for \$1.00. The book number for the David book is not known, but a card to either PCB or Marboro will bring copies of their latest booklists. All books are new hard-cover editions. The minimum mail order from Marboro is \$5.00; PCB's minimum order is \$3.00.

Underwater "saucers," disappearances of ships and planes and the possibility of an undersea civilization are all discussed at Hength and in a most interesting manner in Ivan T. Sanderson's INVISIBLE RESIDENTS (World Publishing Co., 2231 West 110th St., Cleveland, Ohio 44102 6 7 (\$7.50). For many years, reports of UFOs entering and leaving bodies of water have appeared in UFO literature, yet no one had assembled such reports into a comprehensive "whole" until Sanderson tackled the job. This is not to say the t the book is merely dreary repetition of every "sea seucer" report you may have already read. The author does not care for such "seed catalog" listings, although it is felt the t some of the outstanding reports from the UFO periodicals have been omitted here and would have only served to bolster his overall theory. However many reports are given in the book. Sanderson devotes considerable space to the so-called "Bermuda Triangle" and other such anomalistic areas in various perts of the world. This is tied in with ship/plane disappearances and such phenomena as time displacements. Also discussed are "wheels, of light" in the world's oceans and the sightings of unidentified objects in fresh-water lakes and rivers. While one might question the likihood of an indigenous subaquatic civilization, it is entirely likely that UFOs room the waterways of the world at their leisure and perhaps have bases on the ocean floors. INVISIBLE: RESIDENTS makes for good reading.

On rare occasions, a book comes along which displays the dedication of the author in researching his subject and in presenting his material in a logical and readable form. Such a book is GOD, MAN AND THE UFO'S by Ernest P. Moyer (Carlton Press, 84 Fifth Ave., N. Y., N. Y. 10011 - \$6.50). In the main, the Moyer book is a detailed analysis of Jonathan Swif's writings (Moyer believes he was a contactee), comparing Swift's statements with the utterances of modern contactees. As the title suggests, the subject of UFOs and religion is discussed at some length in the Moyer book, along with comments on history and pre-history. On realizing that Carlton Press is a subsidy publisher, i.e. Moyer paid his own publishing expenses, it is obvious that he did not write the book with any thoughts of financial reward. Even if you may not agree with the ideas put forth by Moyer. at all times, you will be hard put to find a book reflecting more genuine research. GOD, MAN AND THE UFO's is highly recommended.
