ARTHUR JAY EPSTEIN It is with deep regret and a sense of personal loss that we inform you of the death of our staff member, "Art" Epstein, who died of nodular lymphoma or Hodgkin's disease, Friday, July 23, 1971, at the Deaconess Hospital in St. Louis, Mo. Services were held at the Christ Church Cathedral in St. Louis on Monday at 2 P.M. and interment was at the Lakewood Park Cemetery.

Arthur Jay Epstein was born and reared in St. Louis until his high school years when the family moved to California. He graduated from Hollywood High School, then returned to Missouri to attend the University at Columbia where he received his B. S. degree. In 1945 he married the former Virginia Winkler, and they made their home in a suburb of St. Louis.

Their only son, Jay, is now a senior at Webster College. For the past ten years, Art was employed as a chemist for the Sigma Chemical Co. He was an active member of Christ Church Cathedral (Episcopal) for 25 years, serving the church during that time as the Boys! Club Swimming Instructor, Church School Teacher, Lay Reader, and Chapter Member. His association with the Boy Scouts saw him as Cub Master, Assistant Scoutmaster and Explorer Advisor.

He enjoyed many hobbies such as photography, woodworking, and gardening --but his desire to learn more of the UFO phenomena was without a doubt his greetest interest. His files on the subject date back to 1957 and he collected everything he could possibly find on the subject. He was a charter member and helped organize the UFO Study Club of Greater St. Louis and was happy in having a part in seeing it incorporated into a non-profit organization, and in the success of the Second Annual Midwest UFO Conference held in St. Louis on June 12. He also found time to serve as a staff member on SKYLOOK.

Your editor never had the pleasure of meeting Art in person, but we talked to him on the telephone and corresponded with him--but knew him best through his many friends through their frequent mention of the fine work he was doing and their warm friendship with a good man. He will be missed--but not forgotten. We know you join us in extending sympathy to his family. of the world that he had

Boy Sees UFO Near Home in Decatur, Ill.

David Krause, age 11, 116 Point Bluff Drive, Decatur, Ill., saw a UFO near his home about 8:25 o'clock the morning of June 22, 1971, and

reported the sighting to Leonard Sturm, MUFON investigator.

David was taking his little dog out in the backyard for a morning walk. He sat down on a lawn chair where he had a veew past the east side of his house to the house across the street as he looked north. There were trees in the foreground with dead branches directly in his path of view. Across the street is a three phase spacer cable power line - 12 KV - in front of the house. He first noticed the object above the top of the IV entenna on the east end of the house across the street -- above the elevation of the power line. Although he did see the object thrrough the tree branches, they did not significantly block his vision.

The youth described the object as being orange in color and bellshaped. It was all one color -- no highlights or shadwos and no reflection of the sunlight. It was plane in appearance, like a flat piece of orange paper. It seemed very large - he commered it to the size of an orange held at arms length and he thought it was a quarter to a half mile distant. The object was hovering when first seen, then moved to the boy's left (to the west), and then back toward the right until it reached the place where first seen. The boy wes guite positive about this movement because he was watching it through the dead tree branches in the immediate foreground. When the object returned to its starting point, just above the TV anethna, its color changed from bright orange to red, and then it "just disappeared."

The sky was clear, with no wind. There was no sound, and the little dog seemed unaware of the object. (Reported by Leonard Sturm)

1967 Landing Site Reported

Mrs. "Smith" was awakened at 2 o'clock the morning of March 21, 1967, because of the warmth in the room in the farm home on a blacktop road off Route 161, about five miles from Mascoutah, Ill. Getting out of bed to remove a comforter, she was aware of a brilliant light in the field to the south and she awakened her daughter. Both observed a large, glowing object for about 10-15 minutes Orange in color and oval-shaped, it had a light in the center and a ring of red lights circling the middle. Yellow light sources near the base were separated by bright metal. The whole glowed with the brightness of the moon, but the red lights were extremely bright.

Both women-were frightened. Mrs. "Smith" opened a window for a betteview; and at that instant, the object rose at an angle toward the east. leveled off at about 30 feet, turned south for about, a half mile, then moved west along the railroad and disappeared behind trees in the dis-

tance. There was no sound.

Because of rain and mud, the women did not visit the landing site until March 23rd. They found a large circular area, measuring 54 feet: across, with all plant life completely withered. There were several depressions about 3 feet across and 10 inches deep, containing a vilesmelling brownish liquid outside the circle.

Clarence O. Dargie, MUFON investigator, visited the site with Mrs. "Smith" on July 21, 1971. The circular area is still very visible and contains only a few stunted plants althorthe rest of the field is in

good clover cover.

For several months prior to the sighting, a great deal of difficulty had been experienced with lights dimming, appliances refusing to operate properly and radio and TV failing to function (altho working perfectly when taken to a repair shop). Following the sighting, no further (Reported by ClarenceO. Dargie) trouble was experienced.

TO THE REPORT OF THE PARTY OF T Robert R. Parsons, of 14852 Phelps Drive, Bridgeton, Mo., recently gave John F. Schuessier a good report of an object seen in 1966.

Mr. Parsons who is employed by Strother and Associates, Inc., of ... St. Louis, Mo., was en route to Kansas City for a Monday sales meeting, traveling from St. Louis on I-70, Sunday evening, March 27. He was enjoying the drive, admiring the early Spring country-side, the lighted church spines in the little towns and observing the scenery as he drove.

When on the Blue Springs cut off (Blue Ridge Blvd. and 104th St. 114 in Hickman Mills) he wotined aglight ahead which he judged to be a---nother church spire in the distance. As he drew nearer, he realized it was not attached to the ground, rather it was moving near the ground, at an altitude he estimated at 300-500 feet at a research of the state of the

The stopped his carrand get out to observe the object. Another car, a Volkswagen, with a man, woman and three children inside had also stopped and one asked; Parsons; if he was watching the "flying saucer."

As the light came nearer, it could be seen to have a definite shape "like a lantern," Parsons said. It came as close as a half mile and ... he judged it to be about 15 feet in diameter and slightly less in height. It was light vellow with a burnt orange band around its center. It was quiet along the road where the two cars had stopped, and he ob-

served the object made no noise. Parsons said he couldn't tell if there was anything above or below. the light as that was all he could see. The time was approximately 8:50 p.m. The object had been coming from the south, growing steadily larger, when it made an abrupt turn to the west and immediately started to. gain altitude at a sharp angle. When it reached an altitude of approximately-15,000 feet, it changed color. It became exceedingly bright like a carbon arc hight (like a large movie projector). The color was a bluish-white glare. The object then sped out of sight in a matter of

seconds. Parsons didnot ask the names of the other witnesses. One told him a similar incident had taken place a year earlier. Parsons is a Naval Reserve Pilot (20-20 vision); a private pilot, served on active duty with the US Navy as a pilot, and considers himself a good observer, although not acquainted with the UEO phenomena. He gave Mr. Schuessler the report because he knew him personally through their business relationship for several years and knew; of his interest in UFOs.

Saucer with Streamers Observed in Missouri

Mr. X and his mother, of Sweet Springs, Mo., reported to Ted Phillips they observed what was described as "a saucer with streamers of multicolored fire "moving slowly towards the southern horizon near dusk on July 12, 1971. The sky was not yet dark and the witnesses watched the object until it was out of sight. UFOs Along Carlyle Lake, Ill.

Mrs. Rosetta Holmes, of Carlyle, Ill, and Terry S. Turner, of Beckemeyer, Ill., MUFON investigators, hearing of unidentified lights being seen along Carlyle Lake, made a quick trip to the area on the night of July 1, 1971, and report five separate sightings between 9 and 10:45 PM. Whether five different objects, or only one or more, were seen cannot be determined.

As they drove along the west side of the Lake, between Carlyle and Keysport, Ill., Mrs. Holmes was the first to spot the object which vanished almost immediately, then reappeared and was seen by both for a few seconds. Turner described it as being a brilliant yellowish-orange light, approximately twice the size of Venus as first seen when it rises in the evening. The object was sighted over the western horizon at a low altitude. While the sky was overcast, the object did not appear to be obscured by clouds when it disappeared—it simply vanished—"went out like a light bulb," Turner said.

Drivin g north for another mile, Turner was turning the car around in one of the parking lots for the boat docks on the lake when Mrs. Holmes saw the second object. Both left the car for a better view and the description was the same as for the first one. Turner watched it through binoculars (l0x50mm) and said it appeared quite the same as a planet appears when viewed through binoculars—a clearly defined dot of light. As Mrs. Holmes took her turn with binoculars; the object rose from its former stationary position above the western horizon and she lost sight of it. Turner was able to catch it again with the binoculars before it disappeared from view. Neither could see it again with the naked eye althouthey remained in the area for five minutes or more in a futile attempt to relocated the object.

Driving on, they had just passed a tavern when Turner saw an object traveling across the sky in a west-southwesterly direction. They again stopped the car and viewed the object with binoculars. Several cars passed by, and they were unable to get a good view of the object which, like the first two, disappeared within a few seconds. Its motion ap-

As they were turning into the road leading into Keysport; Turner again saw an object hovering in the northwest sky. Its description and altitude was the same as that of the earlier sightings. It vanished almost immediately.

On returning to Carlyle at 10:45 PM Mrs. Holmes again saw the object hovering over the western horizon. They stopped the car and as Mrs. Holmes tried to focus the binoculars, the object started to move slowly in a northerly direction and then "it went out like a light bulb," vanishing before the binoculars could be fixed on it.

All the objects, or lights, were of the same general description and with the exception of the third sighting, were first seen hovering at low altitude over the western horizon. A check of SKYLOOK's "Astronomy Corner" indicated that none of the visible planets could have possibly been seen in the western sector of the sky at the time of the observations. Both are convinced the object—or objects—seen were UFO's. (Credit—Terry S. Turner)

UFOs Light County Sky Again -- headlines four columns wide in the July 22nd issue of the "Canton Daily Ledger" was preceded by another headlined report in the July 20th issue. We are indebted to Ed Sales, of Canton, for both reports which follow in the order of their appearance.

July 20, 1971. An aircraft has flown all the way from Quincy to Fulton County without an engine -at least notengine was heard by police officers from here to the Mississippi River as they looked into the sky

for an "unidentified flying object."

The Fulton County Sheriff's night patrol received a radio message Monday night from the Illinois State Police in Macomb, A UFO had been sighted, the State Police said, in Hancock County over Warsaw. Then a call came from Astoria that the craft had been sighted there. There were reports of sightings from Cuba and Havana also

The object has been described most frequently as "looking like a" small aircraft, but going too fast and making no engine sound." Some re-ports are that the object has been sighted for the past three evenings. A State Policeman in Macomb said it was "orange with red and green -

In the hour and a half that Feger was in the field he said he counted 38 falling stars and thought that might have something to do with all the sightings of UFOs. He said it seemed like an unusually high

None of the police officers questioned wants to believe he saw some thing unknown to man, but none will discount the fact that he saw "some-thing really eerie."

Hinds was up early and ready to go to work on the night shift when a call came in from Cuba that UFOs were being spotted. "It came from the west," he said. "And it stopped. And it is not just Fulton County residents who are seeing the UFOs. People in Mencer County near Rock Island reported seeing the same thing Hinds saw -an object moving in, hovering and moving out. And the State Police from Macomb were calling on their radios that they were seeing UFOs. One State Trooper in Adams County saw one and radioed to Fulton County that he was watching it.

"I don't think we're all seeing different things " Hinds said." happened around midnight and we didn't see our's until 1:30."

Hinds said he cannot explain the phenomenon, but is beginning to

believe that "someone is watching us."

"I don't know if some one is watching us or if it's debris from what

we've sent up.".
He said students were at the high school early this morning with telespopes trying to get a closer look. Binoculars make it look like a larger star," he said.

Observers: Myself and my wife.

This is one of the best sightings I have had concerning these objects, in that it was in daytime and I was very close to this craft.

My wife and I were driving north on highway 6, but we were still in Marlin City Limits. There was a bright flash of light that caught the corner of my eye to the northeast. Then I saw that it was some type of craft reflecting sunlight. I thought that it was perhaps a small private plane. It was moving west at a slow speed and I knew it would come across highway 6 up ahead, so I speeded up to check it out just for curiosities sake. My wife was also watching the object; she was also telling me to slow down! (My wife, before this happened was a skeptic, who thought I had an unusual hobby Really, she thought it was crazy, but obviously she didn't want to tell me that; as we had

been married only three months.)

I was now out of Marlin on highway 6 and the object was east of me at ab out 30 degrees from the eastern horizon moving in my direction. I slowed down and we noticed that it was not an airplane, and then my wife cried out, "It's a flying saucer, Tommy, a real flying saucer, just what you have been telling me about."

It was moving an an angle now, moving toward the northwest. So I drove on, wanting to get out, yet knew it might cross over the high-way ahead, where I could get a real close look. As it drew closer, I could see for the first time in my life, at beautiful craft, with prismatic colors reflecting off the dome and its silver-metallic body. I was filled with a tingling in my brain and my heart was ready to come out of my mouth. My wife was so excited, she looked as if swere in a trance, gazing at the craft.

Now I could see every detail. If I would have had a camera, I would have one of the best photographs available today. There was no sound and it appeared to glide through the air. Every once in awhile tilting to reflect sunlight off the highly polished surface. I also noticed an orange light which surrounded the object, similiar to a heat wave. Not a light, but a glow which pulsated. The dome was transparent; inside the dome appeared to be some type of cone which was black which extended upward to some type of lens. This lens appeared to be created the orange glow I mentioned. Around the rim were were small black rectangles, which looked like vents of some kind. They might have been windows, I don't know. Underneath the bottom of the craft was a dark band which seemed to revolve counterclockwise. Also indentations which could have been retractable landing gear.

The craft was at altitude of about 300 feet, I estimate. It new flew directly overhead at an angle. When it reached the other side of the highway, it tilted and then dipped back across the highway in front of us. All this time we were still moved no forward. No cars on the highway except for a truck which was headed toward. Marlin.

It (the object) seemed to observing the highway, because it repeated its maneuvers three times. And finally went off across this field toward the west, rising in altitude. Then it shot straight up, traveling extremely fast until it disappeared into the blue sky. Never in my life have I experienced such a sensation of exhibitation. My wife is a firm believer now, since she has witnessed what few people get to see.

And now, let us return to the question which has been presented in the above title... The reasons, which are making me ponder, reappear over this question, has its origin in these two case sightings, which I myself witnessed in Sofia (the capital of Bulgaria) in the last part of November of 1967 and also in Jicin (a town in Czechoslovalia) in the beginning of the summer of 1968.

I-will begin with the observation of the start of summer of 1968. I can not recall the day, but I do remember it was in the last part of the month of June, it took place. I was strolling in the square (equivalent, to the downtown sections in American cities) of Jicin that afternoon; and I was thinking about how my vacation was going to turn out this year. The weather situation was influenced by a cold front; over our country and the sky was covered about one third with clouds. which were moving very rapidly across the sky, being blown by a strong westerly wind current ... At this time, while observing the rapid movement of the clouds, I sighted in the northwest section of the sky, about 40 degrees above the horizon an object, which had the shape of asymmetrical triangle (side A equals side B, which equals side C). The side (A) which connected the two edges, was oriented almost vertically and the object had its third tedge pointed directly to the east.

The object in question was in its size about half a degree and its diameter was as large as "the nail of the smallest finger." The object's surface resembled that of a metallic surface, which was not very shiny at the time. The sun at that time was hear its southern direction. I observed this object for approximately 25 minutes, and all during this time, the object remained stationary. It remained in that one place during the entire observation. After this period of time the object disappeared, but just before that happened about one minute previous to the disappearance), a haze or what looked like a cloud began to form around the object, until all that was visible was a cloud, and that was the end of it. I was not able to observe it or find it again in the sky after this cloud developed around it. in the sky after this cloud developed around it.

In the upper peninsula of the state of Michigan there is evidence of some very old mining operations, dating back five thousand or more years. An estimated five hundred thousand pounds of native copper was taken from this area over a period of years, but there is no sign of any settlement, or the remains of any of the people that worked there. Native copper, from its make-up of trace impurities, can be traced to known copper areas, but all of this copper has disappeared! One investigator is searching in the country of Greece for artifacts made from this copper. What if none of this metal can be located? The last month of 1970 produced a good UFO sighting in Australia, where an unknown object hovered for two hours over an open pit mining operation. The observers, who were workers at the mine, became uneasy and have demanded an investigation. In the same nation not too long ago, a core drilling crew, that was dribling for minerals, had a whole rash of UFO sightings from their camp. Rumors have it that UFOs have been taking an interest lately in coal mining operations in the eastern part of the United States. Prospectors, mineral property owners, and mine officials have had some very good; if not disquieting experiences. with these unusual craft. Some Canadian mineral property owners saw a circular craft on a lake, and the occupants of the vehicle were out on the deck walking around . This happened while the property owners. were inspecting their property in 1914! A similiar sighting was observed in 1957 in Canada, but at a different area by a mining official and his family. Prospectors have not been left out of this, as shown by the almost disasterous contact near Falcon Lake, Canada. Men of the same trade have been occupants, watched as a UFO "took samples" from ... a mine tailing dump, and also observed EM effects on their compass. Arizona and New Mexico have been "hot beds" of UFO activities in the not too distant past. Atlange part of the economy of these two states come from mine operations. Very few of these numerous reports mention. ed anything about the mining area in which UFOs were observed, and only a person that is acquainted with these areas would start putting two and two together. I doubt that any of the ambitious computer data banks being compiled on UFO sightings contain any of this important information. One would be surprised if he knew just how many good UFO reports have come from mineralized areas. Considering the vastness of the territory of the United States, the actual mining areas are small in compenison, and the fact that so many sightings have been observed around above mentioned places seem to be more than a coincidence.

What are the intentions of the UFOs and their occupants toward our minerals? Do the ET 's want some of this wealth for themselves? Are they just checking their geophysical instruments against what has been found here to see how well their equipment works on Earth? The they checking our accuracy as mineral finders and seeing how well we are able to develop what we have? Are they getting an estimate of time that we have let when all these important minerals will finally be depleted?

Or, is this interest in our mines just idle curiosity?

There has been considerable speculation in the past about UFOs being interested in fault, lines that criss-cross the nation and the world. Earthquakes are the first thing that comes to mind when these fractures in the Earth's crust are mentioned. RACED WITH THE AIRSHIP
Wabash Passengers Saw the Thing Last Night
FASTER THAN THE TRAIN

The Wabash Train Which Arrived Here Last Night Raced With the Airship for Fifteen Miles-Quincy People Among the Passengers

The Wabash passenger train which arrived here at 10 olclock last night had a race for fifteen miles with the airship that is skylarking around the country. The train was running forty miles an hour and kept up with the strange thing for the distance stated but then the airship pulled ahead of them and disappeared. It was seen by Conductor Charles P. Malley and all the passengers, and there was great excitement on the train. Among the passengers who are known to Quincy people and are thorougly reliable were Henry C. Cupp of Fall Creek, Myron E. Lusk. the insurance traveler for Frank Riggs' agency, John Lawson and Oliver Peacock, the porter of the train. All of the passengers and train crew saw it and watched it closely with the greatest interest. And they are all_willing to vouch that it wasn't a star or a balloon.

The strange thing in the sky was first seen near Perry Springs, fifty-two miles east of Quincy, and it was about half a mile south of the train. There was a bright white light and close to it a red light. The red light was not visible all the time, but would appear and disappear, while the white light was constant and steady, and shone with considerable brilliancy. The thing was so far away from the train that they could not make out the form of it or see much else but the lights.

The course of the airship was generally parallel with the train. It had a sort of wave-like motion, up and down. When first seen it appeared to be about 200 feet above the earth, but it was constantly changing its altitude. At times it would swoop down close to the earth, and then with the same graceful motion would rise to a height of several hundred feet. That motion convinced them that it was not a star or a balloon, and there was not enough breeze to carry anything along at the rate of forty miles an hour and more/without some other mode of propulsion. A breeze of forty miles an hour would be a beavy gale, and they could see by the trees that the air was almost perfectly still. Moreover, the smoke from the engine showed that what little breeze was stire ring was blowing in a direction different from that taken by the airship

It kept even with and just a little ahead of the train for fifteen miles. It never came closer to the train than about half a mile, but, as stated, varied its altitude greatly. The unique race was a most interesting one. Through Versailles they went, and when the train slowed up at the station, the airship also slackened speed, so as to maintain about the same position. When they pulled out of Versailles and the train increased its speed, the airship did likewise, and on they went, side by side to Herman. Then the airship seemed to become tired of the race, although the train was running full forty miles an T hour, the thing suddenly shot ahead with a burst of speed that left the machine on the rails bar behind in a few minutes. THE ASTRONOMY CORNER. The September Sky After August 27th Venus will once again be the evening star. It may be seen just after sunset, setting about 7:00 on Sept.

Mars is still the most brilliant sky object in the evening sky although it will be growing fainter as the month progresses. It may be seen throughout the evening in the southern sky, setting at 3:00 a.m. Sept. 1st and at 1:30 a.m. Oct. 1st.

Jupiter can be seen in the early evening sky setting at 10:10 p.m.

Sept 1st and 8:20 p.m. by Oct. 1st. It is seen in the south-southwest. Saturn is seen during the late evening as it rises at 10:45 p.m. Sept 1st and 9:10 p.m. Oct. 1st. It is also seen in the southern region. (By Ted Phillips)

The Constellations. No. 10. Cygnus (The Swan) Cygnus means "the Swan." Almost every culture has identified Cygnus with a bird. The Arabs called it an eagle. Cygnus is one of the prominent northern constellations. It culminates at 9 PM on Sept. 13 and is directly overhead at the latitude of New York City. The constellation is also called the Northern Cross, which is formed by 5 of the brightest stars. The brightest star in Cygnus is Deneb which marks the tail of the Swan. The word Deneb is Arabic for "The Tail." Deneb is a tremendous hot; blue star. A beautiful double star, Albireo is located at the head of the Swan. It is an optical double -- one star is blue, the other gold in color.

Bessel-determined the distance to the star 61 Cygnie in 1838 and gave it 10.3 light years. Amont all the naket eye stars 61 Cygnie is the fourth nearest to the Earth. 61 Cygnie has angunseen companion; revolving around it which is eight times the mass of Jupiter and there is some question whether it should be regarded as a star or a planet. In this constellation the amateur astronomer with a small Rich Field telescope can observe two of the most beautiful objects in the Milky Way galaxy. They are: the Veil Nebula which is thought to be a super-nova remnant, and the North American Nebula. These nebula are vast clouds of hydrogen and other gases. NATIONAL ENQUIRER continues to feature UFO material from time to time. The August 8 issue contained an article on Australian sightings and a landing site; an article by Stanton T. Friedman appeared in the August 7 ssue; and the September 5 issue reported on the reader poll concering UFOs which was recently conducted by INDUSTRIAL RESEARCH magazine.

The September issue of FATE has an article by APRO's Coral Lorenzen which concerns various Brazilian UFO sightings and occupant reports.

A recent book dealing with the contactee side of the UFO picture is Fred Steckling's WHY ARE THEY HERE? -- "they" being spaceships from other planets, of course. Mr. Steckling, a good friend of the late George Adamski, relates his own personal experiences with the "space people" and expounds their philosophy as he understands it. He tells about his European lecture tour and the "armada" of cigar-shaped UFOs filmed by him in Germany. The "stills" from his movie film (two of which are included in the book) are indeed most interesting and seem worthy of further study. The contactee phenomenon is, and has always been, one of the most controversial aspects of Ufology. It has been felt by many that all contactee stories should be dismissed out of hand, as they serve only to "degrade" serious research. However, in order to achieve a comprehensive view of the entire subject, all facets of the enigma must be considered. In reading Mr. Steckling's book, it is obvious that he believes implicitly in what he is saying. Ufologists should attempt to ascertain the "why" of such steadfast conviction, rather than ignoring such testimony. For those who are interested, the book is available from Vantage Press, Inc., 120 W. 31st St., N. Y., N. Y. 10001 for \$3.95. SCIENCE, THE PUBLIC AND THE UFO by Arthur Bray was first published

SCIENCE, THE PUBLIC AND THE UFO by Arthur Bray was first published in 1967, but SKYLOOK readers may be interested in knowing that the book is still available. Admittedly, the book contains a considerable amount of material which has been reprinted from various UFO books and periodicals, as well as other relevant publications. This should not be a deterrent, however, as Mr. Bray synthesizes his Ufology, science and philosophy in a quite readable blend. For those just now becoming acquainted with the UFO subject, this would be a very good primer. One thing which attracted my attention was Mr. Bray's comments on specialization in UFO study. With reference to the many "branches" of the subject, the author says: "Taken individually, it is often difficult to see the interrelationships and overlaps among all these subjects, but when the broad view is taken of all of them collectively, a definite picture emerges. Only in this way can one appreciate the meaning and significance of the mystery." Well worth perusing, SCIENCE, THE PUBLIC AND THE UFO is available in hardcover for \$6.00 and in paperback for \$3.00 from Bray Book Service, P. O. Box 5051, Station F, Ottawa, Ontario, Canada K2C 2H8.

One is tempted to say that Paris Flammonde's THE AGE OF FLYING SAU-CERS is merely 288 pages of re-hash. Alas, for the confirmed "Ufonut," this is largely the case. Mr. Flammonde's original intention was to write a massive and comprehensive tome which would be a definitive history of the "flying saucer era" which began in 1947. Plans for such a volume have temporarily been shelved, so this book is something of a preview of the larger, yet-unfinished work. If your UFO reading has been fairly comprehensive over the years, you will find virtually nothing new in the book. It does contain some good photos of various UFO
